Re: Appropriation of Funds – Activity & Recreation Center Capital Improvement Project

Executive Summary

The Parks and Recreation Department is requesting City Council approval to appropriate \$275,000 in Park Sales Tax funds for the Activity & Recreation Center (ARC) capital improvement project. The additional funds are needed to complete the building foundation repairs on the west side of the facility. The project was approved by the City Council on Jan. 17, 2023 and staff is ready to finalize the contract for completion of the foundation repairs to Foundation Recovery Systems. The work will begin after final execution of the contract and is anticipated to be completed by early fall 2024.

Discussion

As part of the Activity & Recreation Center (ARC) capital improvement project approved by the City Council Jan. 17, 2023, park staff requested permission to proceed with building foundation repairs on the west side of the facility. The ARC foundation settlement has caused cracks to propagate in the facility's brick and CMU walls, columns, floors, and the exterior sidewalks. The foundation settlement issues need to be stabilized before the issues diminish the structural integrity of the building.

Park staff worked with Simon & Struemph Engineering to develop the scope of work for the project and the project was bid through the City's Purchasing Department. After review of the bids by multiple vendors and a recommendation by the engineering firm, the department has selected Foundation Recovery Systems to complete the necessary work to stabilize the foundation of the building. It is anticipated that work will begin once the contract is executed and should be completed by early fall 2024. Staff has a desire to complete this work while the ARC Water Zone is shut down this summer, as traffic in and out of the building will be reduced due to the closure.

The appropriation of Park Sales Tax funds, totaling \$275,000, is necessary to complete the entire scope of work suggested by Foundation Recovery Systems and to replace the exterior sidewalk that will have to be removed to complete the work by the contractor. Foundation Recovery Systems provides a lifetime warranty on all completed work and Simon & Struemph Engineering will provide construction oversight throughout the project.

After completion of the stabilization work and sidewalk replacement by the contractor, park staff will repair the visible cracking in the facility's walls, columns, floors and sidewalks.
