

**NOTICE FOR PUBLIC COMMENT AND HEARINGS**  
**Substantial Amendment of FY 2019, FY 2023 and FY 2024 Annual Action Plans**

The Columbia City Council will hold a Public Hearing on July 7, 2025 at 7:00 p.m. in the Council Chambers of City Hall, 701 E. Broadway. On May 14, 2025, the Housing and Development Commission recommended Community Development Block Grant (CDBG) reallocations from FY 2019; CDBG and HOME funding reallocations from FY 2023; CDBG and HOME reallocations from FY 2024. If approved, these reallocations will require amending the FY 2019 Annual Action Plan, FY 2023 Annual Action Plan, and FY 2024 Annual Action Plan.

Copies of the draft documents are available at 11 North 7<sup>th</sup> St., Columbia, Missouri and at [como.gov/housing-programs-division](http://como.gov/housing-programs-division). Public comments will be accepted for the FY 2019 Annual Action Plan amendments, FY 2023 Annual Action Plan amendments, and FY 2024 Annual Action Plan amendments until 5:00P.M. on July 11, 2025. After the Public Comment Period and Hearing, the amended FY 2019, amended FY 2023, and amended FY 2024 Annual Action Plans will be submitted to the U.S. Department of Housing and Urban Development (HUD) for approval along with public comments received and responses to those comments.
