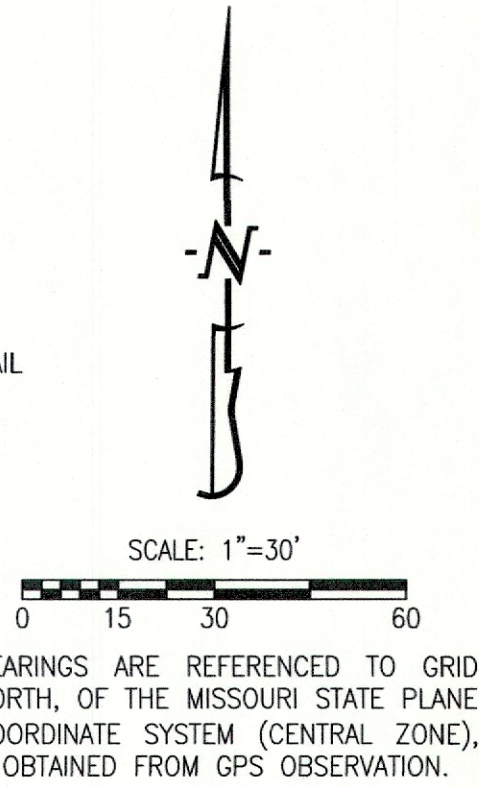


LOCATION MAP

FLOOD PLAIN STATEMENT:

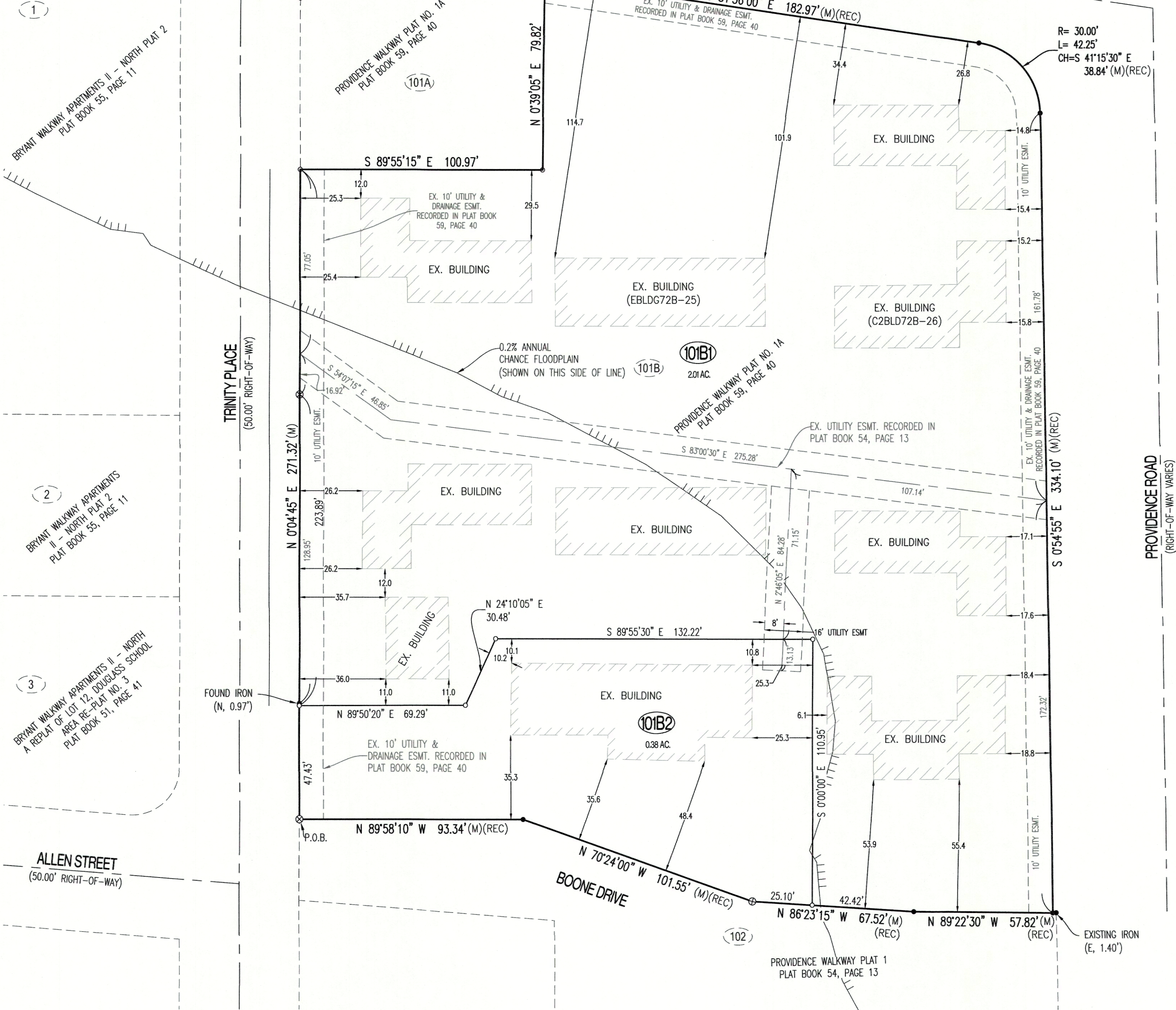

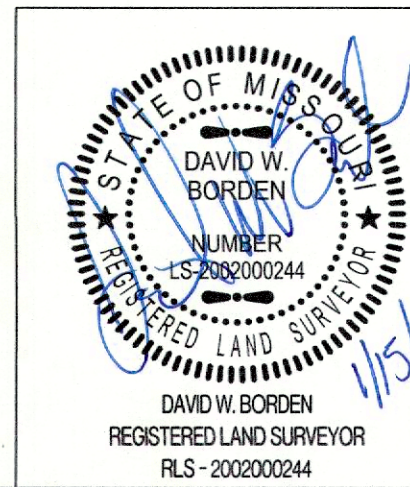

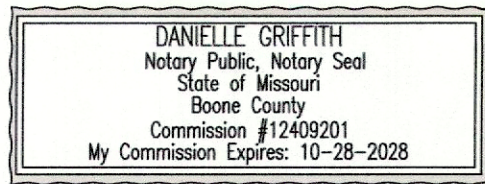
