SUBJECT: Power Cost Adjustment Report – October FY24

The following is a summary of the power cost adjustment (PCA) determination for October 2023 and is intended to serve as the required quarterly update for the Water & Light board.

Projected Expenses

Staff are forecasting an increase of \$2,556,003 in power cost over the currently projected FY23 level. This is mainly due transmission and natural gas expenses being lower in FY23 than is typical combined with higher than normal transmission revenue.

Projected Power Cost Recovery

Staff are forecasting an increase in energy sales in FY24 of 39,069,062 kWh. Mild monthly average temperatures in both the winter and summer seasons resulted in lower than typical energy usage in FY23. This corresponds to forecasted base rate power cost recovery of \$68,309,014in FY24, which is \$332,318 less than current projected power cost expenses.

The calculated PCA for October 2023 is \$(0.000276). This will result in a bill credit of \$0.21 for the average residential customer.
