Re: Ordinance Authorizing CDBG and HOME affordable housing agreement with the Columbia Housing Authority (CHA) and Providence Walkway Housing Development Group, LP, to renovate and develop Providence Walkway apartments.

Impacted Ward: Ward 1

Executive Summary

Approval of the ordinance will authorize the City Manager to: (1) execute a Community Development Block Grant (CDBG) and a HOME Investment Partnerships (HOME) funding agreement with the Housing Authority of Columbia (CHA) and the Providence Walkway Housing Development Group, LP in the amount of \$320,000 and \$150,000 respectively, for the Providence Walkway Project secured by a fifth and sixth position (CDBG and HOME) deed of trust and promissory note.

Discussion

Columbia Housing Authority (CHA) and its partner entity, the Providence Walkway Housing Development Group, LP (hereinafter, collectively referred to as "the Property Owner"), plan to replace existing public housing units along Trinity Place and Pendleton Street with new and rehabilitated affordable housing units through Rental Assistance Demonstration (RAD) conversion. The existing units were constructed in 1965 and have exceeded their life cycle. The units have foundation problems, electrical issues and collapsing sewer lines. CHA's current plan includes 16 units to be rehabilitated and 9 new construction units and will include (12) 4-bedroom, (4) 3-bedroom, (3) 2-bedroom, and (6) 1-bedroom units. The plans will include improved accessibility and energy efficiency.

On April 1, 2024 the City Council authorized an affordable housing funding agreement with the Property Owner for the development of the Project. The agreement authorized the use of \$3,000,000 in American Rescue Plan Act (ARPA) funds provided in the form of a 0% interest, 20-year forgivable loan, payable upon title transfer and secured by a deed of trust dated April 8, 2024. The first amendment to the agreement extended the 50% and 75% expenditure deadlines to March 31, 2026 and June 30, 2026, and moved up the 100% expenditures deadline to October 31, 2026 to better align with the RAD conversion timeline and keeping with ARPA expenditure deadlines.

Finally, this Ordinance will authorize the execution of the CDBG funding agreement in the amount of \$320,000 and the HOME Investment Partnerships funds agreement in the amount of \$150,000. The funds will be provided as 0% interest loan due upon sale or property use that does not comply with requirements prior to the discharge date, with a maturity date of December 31, 2057.

Fiscal Impact
