FIRST AMENDMENT to the 2022 SOCIAL SERVICES PROVIDER AGREEMENT

This Amendment to the 2022 Agreement between the CITY OF COLUMBIA ("City"), and AAAAChange, LLC, a limited liability company organized in the State of Missouri, ("Provider") is made as of the date of the last signatory noted below ("First Amendment Effective Date").

RECITALS

- A. WHEREAS, on August 2, 2022, City and Provider entered into an Agreement ("2022 Agreement") for street outreach and case management services for unhoused persons; and
- B. WHEREAS, the Parties hereto desire to formally amend the 2022 Agreement with this First Amendment (hereinafter "First Amendment") and desire to be bound by the terms contained in the 2022 Agreement as amended or supplemented by those terms contained in this First Amendment.

<u>AMENDMENT</u>

NOW, THEREFORE, in consideration of the mutual benefit to be derived by the parties, it is agreed to amend the 2022 Agreement, as follows:

- 1. Section 1(b) of the 2022 Agreement shall be removed and replaced with the following:
 - "b. Total Allowable Compensation for the Program Services
 - i. For the Initial Term (8/2/2022-12/31/2022), the total allowable compensation for the Program Services shall not exceed ten thousand, six hundred twelve dollars and fifty cents (\$10,612.50).
 - ii. For the First Renewal Term (01/01/2023-09/30/2023), the total allowable compensation for the Program Services shall not exceed sixteen thousand, eight hundred and twenty-five dollars (\$16,825.00).
 - iii. For the Second Renewal Term (10/01/2023-09/30/2024), the total allowable compensation for the Program Services shall not exceed fifty thousand dollars (\$50,000.00).
 - iv. For any additional renewal terms, the total allowable compensation for the Program Services shall not exceed fifty thousand dollars (\$50,000.00)."
- 2. Section 2 of the 2022 Agreement shall be removed and replaced with the following:
 - "2. DURATION

- a. Initial Term: The initial term of this Agreement shall be for a term commencing on the Effective Date (8/2/2022) and ending on December 31, 2022.
- b. First Renewal Term. The first renewal term of this Agreement shall commence on January 1, 2023 and continue through September 30, 2023.
- c. Second Renewal Term. The second renewal term of this Agreement shall commence on October 1, 2023 and continue through September 30, 2024.
- d. Additional Renewal Terms. Thereafter, the Parties may agree to additional, consecutive renewal terms. If the Parties agree to renew the agreement for any additional periods of time, the period of time shall commence on October 1 of the then current year and continue through September 30 of the following year."
- 3. Section 3 of the 2022 Agreement shall be removed and replaced with the following:
 - "3. REPORTING: In the manner, format, and timeframe required by the City, Provider agrees to submit to the City monthly reports."
- 4. Exhibit A of the 2022 Agreement shall be amended as set forth in this section. The Parties agree to remove the columns labeled "Amount not to Exceed" and "Number of Units of Service." The parties agree that the Service, Service Definition, Unit of Service Measure, Service Recipient, and Unit of Service Rates set forth in Exhibit apply to all services performed pursuant to the Agreement. The Parties agree that the not to exceed amounts for each term are set forth in Section 1 of this Amendment.
- 5. All other terms of the 2022 Agreement shall remain unchanged and in full force and effect.
