Re: Memorandum of Understanding with the United States Capitol Police for Reimbursement

of Protective Services Impacted Ward: Citywide

## **Executive Summary**

Staff requests approval for the City of Columbia, Missouri to enter into a Memorandum of Understanding (MOU) with the United States Capitol Police (USCP). The MOU establishes the terms and conditions under which Columbia Police Department (CPD) may, upon request and subject to availability, provide protective support for Members of Congress during events or operations occurring within the City of Columbia.

USCP will reimburse CPD for all agreed-upon law enforcement services, including personnel overtime, equipment and related expenses.

This agreement does not obligate CPD to provide services, nor does it require USCP to reimburse expenses that were not coordinated directly with USCP. The MOU may be terminated by either party with 30 days' written notice.

#### Discussion

The United States Capitol Police is statutorily required under **2 U.S.C. § 1966** to provide protection to Members of Congress when security considerations require it. When Members participate in events within the City of Columbia or Boone County, USCP may request support from local law enforcement agencies to augment protective operations.

Given the growing number of Congressional visits and political events held within Columbia, this MOU formalizes the reimbursement process and clarifies communication channels between the agencies.

#### The MOU:

- Identifies Columbia Police Department as the local jurisdiction providing support.
- Establishes that CPD must voluntarily agree to each request based on available resources.
- Requires CPD to maintain communication with USCP leadership during protective operations.
- Requires CPD to provide itemized expense documentation to USCP after services are rendered.
- Requires USCP to promptly reimburse CPD for eligible expenses.



This agreement benefits public safety by ensuring federal protective operations can be supported without placing unplanned financial strain on the City of Columbia.

## Fiscal Impact
