AN ORDINANCE

amending Chapter 17 of the City Code as it relates to Parks and Recreation fees; and fixing the time when this ordinance shall become effective.

Be it ordained by the Council of the City of Columbia, Missouri, as follows:

SECTION 1. Chapter 17 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 17-161. Fees.

The following parks and recreation fees are hereby established:

(a) *Activities/classes*. Any activity (unless specified elsewhere in this section) that has as its main objective to instruct a participant for the purpose of increasing the participant's skill level, will carry a fee of:

Children (17 and under).....\$3.00—\$250.00
Adults3.00—350.00

The fee for each individual class is based upon the recovery of direct costs associated with the program.

Day camp (per person, per one week session)
Includes \$7.75 user fee..... \$155.00

"School's Out" Camp at the ARC,
includes \$5.50-\$7.75 user fee ~~50.00~~ 35.00-155.00
