Re: Authorizing the City Manager to execute form of service agreements with the Southwest Power Pool, Inc for compliance with tariffs regarding transmission of electric power from Iatan II power plant.

Executive Summary

Staff has prepared for Council consideration a resolution authorizing the City Manager, or the City Manager's designee to execute agreements with the Southwest Power Pool for purposes of compliance with the Southwest Power Pool tariffs regarding the transmission of the Columbia Utilities allocation of electric power from the Evergy Power Plant II located in Iatan, Missouri.

Discussion

The Electric Division of the Utilities Department has a power supply arrangement with the Missouri Joint Municipal Electric Utility Commission for electrical capacity and energy from the Evergy Iatan II power plant, formerly owned by Kansas City Power & Light. The Iatan II power plant is located within the Southwest Power Pool regional transmission operator area. The City's electric utility is located in the Midcontinent Independent System Operator regional area. In order for the City's electric utility to take delivery of the capacity and energy from Iatan II power plant, it must utilize the Southwest Power Pool transmission facilities. In accordance with the Southwest Power Pool's federally filed and approved tariffs, the Utility Department is required to periodically execute documents with the Southwest Power Pool to arrange for transmission services. This resolution authorizes the City Manager, or the Manager's designee, to execute agreements with the Southwest Power Pool necessary to comply with their tariffs. Attachment A represents an agreement for service from October 1, 2018 to October 1, 2023, that Southwest Power Pool realized was not previously executed and is doing so now for documentation for all parties. Attachment B is an agreement that will renew the service effective October 1, 2023 to October 1, 2028.

Fiscal Impact
