AMENDMENT #01 TO CONTRACT ERS16157416

CONTRACT TITLE: Show Me Healthy Women

CONTRACT PERIOD: June 30, 2025 through June 29, 2026

The Department of Health and Senior Services hereby decreases the above referenced contract; therefore Section 2.1.1 is hereby deleted in its entirety and replaced with revised Section 2.1.1 as follows:

2.1.1 The contract amount shall not exceed \$1,500.00 for the period of June 30, 2025 through June 29, 2026.

In addition, the Department of Health and Senior Services desires to amend the above-referenced contract in accordance with the following:

- 1. Delete Section 2.4.1 in its entirety and replace with revised Section 2.4.1 as follows:
 - 2.4.1 Claims under the contract shall not exceed the Total Breast and Cervical Cancer Screening/Diagnostic Funding (Total Funding) of \$1,500.00. At the beginning of each quarter, one-fourth of the Total Funding will be available for the Contractor's use. Contractor shall request prior approval from SMHW central office staff if they need to exceed one-fourth of the total before the end of the first three quarters. Quarters are defined as:

June 30 through September 30; October 1 through December 31; January 1 through March 31; and April 1 through June 29.

All other terms, conditions and provisions of the above referenced contract shall remain the same and apply hereto.
