**FIRST AMENDMENT TO LICENSE AGREEMENT
(PARKSIDE DRIVE)**

THIS FIRST AMENDMENT TO LICENSE AGREEMENT by and between **City of Columbia, Missouri**, a Missouri municipal corporation (hereinafter "City") and **Cellco Partnership d/b/a Verizon Wireless** (hereinafter "Licensee"), is entered into on the date of the last signatory noted below (the "Effective Date").

WHEREAS, City and Licensee are parties to a Parkside Drive Tower Co-Location Agreement dated October 17, 2006 and a License Agreement dated July 2, 2018; and

WHEREAS, the License Agreement allows Licensee to install construct, maintain, operate, repair and replace utility lines, including fiber optic cables and conduit to and from the tower to Parkside Drive on City property; and

WHEREAS, the current location of the Licensee's cable conduit and lines interfere with an intended use by City's Park and Recreation development; and

WHEREAS, the City and Licensee desire to relocate the lines to a new area designated herein; and

NOW, THEREFORE, in consideration of the foregoing recitals incorporated in this First Amendment to License Agreement and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. The "**Exhibit B**" attached to the original License Agreement shall be replaced by "**Exhibit B-1**" attached hereto to this First Amendment.
2. City shall at City's expense provide sufficient conduit in the new licensed area for Licensee to install fiber optic cable to the existing tower. Licensee shall pay for all expenses incurred in installing the fiber cable they require.


