Re: Resolution granting a temporary waiver from the requirements of Section 16-186 of the City Code to allow possession and consumption of alcoholic beverages and Section 16-258 of the City Code to allow amplified family-friendly music for FPC Live, LLC.

## Executive Summary

Staff has prepared for Council consideration a resolution granting a waiver from the requirements of Section 16-186 and 16-258 to allow possession and consumption of alcoholic beverages and amplified family-friendly music for an outdoor event for FPC Live, LLC on behalf of MidMO Pridefest.

## Discussion

Sean Allmeyer, General Manager of The Blue Note, requested a street closure of a portion of Park Avenue between Tenth Street and St. James Street and a portion of Orr Street from Park Avenue until just North of the Columbia Fire Department Administration Building from 8:00 a.m. until 11:00 p.m. daily September 24 and 25, 2022. This event is from 12:00 p.m. until 11:00 p.m. daily with an estimated daily attendance of 1250 people.

Mr. Allmeyer has also requested a waiver from the requirements of Section 16-185 of the City Code to allow possession and consumption of alcoholic beverages within the same street and a waiver from the requirements of Section 16-258 of the City Code to allow amplified family-friendly music for the event.

This event has met qualifications to bring to City Council for approval.

Per City Ordinance 24-73b, an operations agreement is only required for a downtown street closure if the event is to take place the day before, or the day of, any scheduled University of Missouri home football game. The aforementioned requested events are not on University of Missouri home football game weekends.
