Executive Summary

Staff has prepared for Council consideration an ordinance authorizing the City Manager to execute a \$16,000 amendment to an existing agreement with Horizons Energy, LLC for an Electric Cost of Service Study. This will allow Horizons to develop financial projections based on current economic conditions as well as develop a rate for Electric Vehicle charging and develop a replacement option for the current Fuel Adjustment Ordinance.

Discussion

In September 2019, the City entered into an agreement with Horizons Energy, LLC for professional services for an Electric Cost of Service Study. This work is being done in conjunction with the Integrated Electric Resource and Master Plan (IER&MP). Most of Horizon's work required completion of the work done by Siemens for the IER&MP.

Due to the length of the project, the original funds authorized by the initial agreement are exhausted. Staff has worked with Horizon to develop an estimate of the funds required to complete the project, and to include some addition items to the scope of work.

Staff would like Horizon to provide two additional financial projections based on actual information as of December 2021 since the initial test year was during a period of low inflation and interest rates. These two additional financial projections will reflect changing economic conditions, specifically higher interest rates and higher inflation rates. In addition, staff would like Horizon to develop a rate for Electric Vehicle (EV) charging and also to review and develop a replacement for the current Fuel Adjustment Allowance ordinance (Sec. 27-118).

The estimated cost for this additional work is \$16,000, which would bring the total agreement with Horizon to \$84,000. Funding for this additional expense is available in the FY 2022 operating budget.

Fiscal Impact

Short-Term Impact: The proposed amendment will increase the cost of the project by \$16,000.
