

**AMENDMENT TO AGREEMENT
BETWEEN
THE CITY OF COLUMBIA, MISSOURI
AND
THE BUSINESS LOOP CID**

THIS AMENDMENT (hereinafter “Amendment”) to the Agreement Between The City of Columbia, Missouri and The Business Loop Community Improvement District (hereinafter “Agreement”), by and between the City of Columbia, Missouri (hereinafter “City”), and The Business Loop Community Improvement District (hereinafter “District”), is entered into on the date of the last signatory noted below (the “Effective Date”). City and District are each individually referred to herein as a “Party” and collectively as the “Parties”.

WHEREAS, on March 23, 2022, City and District entered into an Agreement for City to provide funds to District towards its operation of CoMo Cooks to help local food based entrepreneurs launch and grow new food and beverage businesses (hereinafter “Work”);

WHEREAS, District has expended most of the funds towards the Work, with one thousand two hundred fifty dollars and no cents (\$1,250.00) remaining unexpended in the scholarship funding category due to a scholarship recipient’s withdrawal from the program;

WHEREAS, District has expended all of the awarded funds in the kitchen construction funding category, and in the equipment purchase and installation funding category; and

WHEREAS, the Parties desire for District to expend the unexpended award amount toward the equipment purchase and installation funding category, and to amend the Agreement accordingly.

AMENDMENTS

NOW, THEREFORE, in consideration of the mutual covenants set out herein, the Parties agree to amend the Agreement as follows:

1. Paragraph 2 of the Agreement is hereby amended by removing the entire paragraph and inserting the following:

2. Term. This Agreement shall commence on the Effective Date and shall continue for a period through September 30, 2026, unless terminated or extended pursuant to the terms set forth herein.

2. Exhibit A to the Agreement is hereby amended by removing the entire exhibit and inserting the attached Exhibit A.

3. The terms and conditions of the Agreement are modified by this Amendment as specifically set forth herein. All other terms of the Agreement shall remain unchanged and in full force and effect.
