Re: Setting a Public Hearing for the Rollins Road Traffic Calming Project

### **Executive Summary**

Setting a public hearing for March 3, 2025 to consider the installation of traffic calming devices on Rollins Road between Fairview Road and Stadium Boulevard. The estimated cost of the project is \$32,000.

#### Discussion

Rollins Road scored as the 2<sup>nd</sup> highest priority project within the 2023 Neighborhood Traffic Management Program (NTMP), with a score of 78.57 out of a possible 100. The scoring system takes a number of factors into consideration including speed, volume, pedestrian generators in the area, proximity to schools, bike routes, and recent crash history. The majority of the scoring (2/3) is based on speed and volume of vehicles. Rollins Road scored at the 85<sup>th</sup> percentile speed of 39.30 mph and has approximately 2,965 vehicles traveling on it per day.

Two Interested Parties (IP) meetings were held for this project. The first IP meeting was held on July 8, 2024. The second IP meeting was held on December 9, 2024.

During the first IP meeting, staff gathered information from the public and listened to potential solutions. The majority of those in attendance and providing feedback were supportive of traffic calming efforts.

Preliminary plans were developed and presented during the second IP meeting. While the majority of those in attendance and providing feedback appear to be supportive of some form of traffic calming, feedback on the proposed plan was mixed.

Staff would like to proceed with the construction of three speed humps and one crosswalk on Rollins Road during the 2025 construction season. The installation of bike lane markings is expected to be completed within the next few years when the current shared bicycle lane markings have faded, or after maintenance activities have removed the current markings.

The calming devices will be located at the following locations:

- Speed hump on Rollins Road near 711 Hulen Drive
- Speed hump on Rollins Road near 2401 Rollins Road
- Speed hump on Rollins Road near 2200 Rollins Road
- Crosswalk with bulbouts at Martin Drive and Rollins Road

# Fiscal Impact

Short-Term Impact: The estimated cost for the installation of a series of three speed humps and a new crosswalk with bulbouts, including signs and markings, is \$32,000 paid from Annual Traffic Calming Funds.

Long-Term Impact: Staff anticipates the replacement of the traffic calming devices every 15 years.
