The CPD Command Staff has discussed various uses for these funds based on current identified needs. One of the highest priorities we have identified is the purchase of a NIBIN (National Integrated Ballistic Information Network) machine from the Bureau of Alcohol, Tobacco, Firearms & Explosives (ATF). This machine gives CPD personnel the capability to capture and compare ballistic evidence to aid in solving and preventing violent crimes involving firearms. When shell casings or firearms are collected as evidence they can be entered into the NIBIN network for comparison. Currently this process takes several weeks or months to receive a response and several hours of staff time as well as shipping expenses just to get the evidence to a NIBIN processing location in Cedar Rapids, IA. By purchasing a NIBIN machine we will be able to process our own NIBIN cases in-house, which increases efficiency and shortens the turnaround time for crucial evidence needed to make a case in a crime involving a firearm. This directly relates to the City's goals for the Office of Community Violence and would aid in quicker identification and apprehension of violent offenders in our community, thus increasing overall safety. We would also act as a resource for other area law enforcement agencies by processing their evidence in the NIBIN system to aid them in solving crimes.

Another high priority is the creation and funding of a technology plan. The first phase of this plan would include body-worn cameras (BWC), in-car cameras, holster sensors that automatically activate the BWC when the officer's firearm is removed from the holster, auto-tagging of video evidence in the Computer Aided Dispatch (CAD) system, and live-viewing capabilities of BWC's. This plan would place all of these tools in the same operating platform, providing for a seamless integration of the technology. It also assists in increasing transparency by reducing the amount of human error that contributes to the loss or lack of video evidence of an event.

It is important to note what these funds can and cannot be utilized for per federal rules:

- Law Enforcement Investigations
- Law Enforcement Training
- Law Enforcement and Detention Facilities
- Law Enforcement Equipment
- Law Enforcement Travel and Transportation
- Law Enforcement Awards and Memorials
- Drug and Gang Education and Awareness Programs
- Matching Funds for state/federal grants
- Transfers to Other Law Enforcement Agencies
