Re: Missouri Department of Health and Senior Services HIV Prevention Contract Amendment 02

## Executive Summary

An ordinance authorizing the City Manager to sign the HIV Prevention Contract Amendment 02 for the period of June 1, 2024 through July 31, 2024. The contract amount shall not exceed \$19,152.

## Discussion

HIV Prevention program funding enables the Department of Public Health and Human Services (PHHS) to provide comprehensive Human Immunodeficiency Virus (HIV) prevention services, which may also include sexually transmitted infections (STIs) and Viral Hepatitis (VH) within the 33 county Central Missouri Region. The amendment extends the current contract by two (2) months and provides \$19,152 in funding.
