Re: Resolution Authorizing a Special Event Operations Agreement with Trio Presents, L.L.C. for the 2022 Roots N Blues Festival.

## Executive Summary

Staff has prepared for Council consideration a resolution authorizing the operations agreement for the Roots N Blues Festival, October 7-9, 2022 at Stephens Lake Park.

## Discussion

Trio Presents, L.L.C. submitted a special events application for the 2022 Roots N Blues Festival. Over 11,000 people attend this three-day festival, which features 24 national, regional, and local musicians. This is the 14<sup>th</sup> year for the festival, which started in downtown Columbia, and has been held inside Stephens Lake Park since 2013.

The City Special Events Committee has worked closely with Trio Presents, L.L.C. to address all aspects of the application and operations agreement and to develop plans including but not limited to: festival layout, traffic management, security plan, emergency plan, alcohol sales, insurance, fees, and solid waste.

Because of the size and scope of this festival and because it requires street closures, as well as city services and equipment, an agreement must be executed between the city manager and event organizer, and approved by the City Council, per Section 24-73(b) of the City Code.

While most aspects remain the same as previous years, the following is the notable change:

- Private security is working this event in conjunction with CPD and they will no longer be utilizing the ROTC students creating a better trained security staff for the event moving forward.

The City Special Event Committee and the Organizer will continue to work together prior to the start of the festival to ensure all plans are aligned with standard best practices and approved by the appropriate city staff and departments to ensure a safe and successful event for all involved.
