
## NOTICE OF PUBLIC HEARING BEFORE THE BOARD OF ADJUSTMENT

Notice is hereby given that the Board of Adjustment of the City of Columbia, Missouri, will hold a public hearing in the Council Chamber of City Hall, 701 E. Broadway, in Columbia, Missouri, at 7:00 p.m. on Tuesday, the 18<sup>th</sup> day of November 2025, to give all interested persons an opportunity to appear and be heard in relation to the following appeal to be known as Case # 336-2025:

A request of Zachary Buchheit (attorney), on behalf of Broadway Office Park Condominium Association (owner) and SBA Towers II LLC (lessee), seeking approval of a conditional use permit to allow for a 110-foot non-stealth cellular communication tower on PD (Planned Development) zoned real estate in the City of Columbia, County of Boone, State of Missouri, hereinafter described,



requesting that said Board approve a conditional use permit (CUP) allowing an existing 110-foot tall stealth monopole cellular communication tower to be converted to a non-stealth tower of the same height on property address as 1205 W. Broadway such that enhanced cellular communication services may be deployed as required by Section 29-6.4(m)(2)(i) and (ii) of the Unified Development Code.

RE: A request of Zachary Buchheit (attorney), on behalf of Broadway Office Park Condominium Association (owner) and SBA Towers II LLC (lessee), seeking to amend the existing 2012 "stealth" communication tower conditional use permit (CUP), on property commonly addressed as 1205 W. Broadway, such that the existing tower be permitted to become a "non-stealth" communication tower. If approved, the current cellular equipment contained within the monopole structure would allowed to be mounted onto the exterior of the monopole with

no increase in tower height. Given the proposed modifications, a new conditional use permit (CUP) authorization is required by Section 29-6.4(m)(2)(i) and (ii) of the Unified Development Code.


