#### **Executive Summary**

This new license agreement would allow the non-profit Wabash Farm & Art Market to use the City's Wabash parking lot to operate a farmers and artists market on Sundays from April to October of each year. Staff is requesting City Council approval of the legislation authorizing the City Manager to sign this license agreement.

### Staff Report

The Wabash Farm & Art Market is a newly incorporated nonprofit corporation in good standing with the State of Missouri. As they did before, the nonprofit group desires to use the City's Wabash Station parking lot on Sundays from April through October in order to continue the operation of the farmers and artisans' market.

Historically, since at least 2014, North Village Arts District Farmers and Artisans Market operated a farmer and artisans' market on Sundays at the City's parking lot of the Wabash Station, 126 North Tenth Street. Currently, the City does not operate the transit system on Sundays, which allows the space to be utilized. Now known as the Wabash Farm and Artisan Market, market vendors utilize the covered structures used for transit busses. The goal of the market is to provide the community with access to fresh nutritious produce, quality goods and unique crafts at affordable prices.

Wabash Farm and Art Market is responsible for all trash removal and cleaning of the Wabash Station parking lot after each use. They are also required to have insurance. Like the agreement with the prior organization, the City is not charging the nonprofit to utilize the space. Should the City need the space on a market day, this Agreement authorizes the Director of Public Works to provide an alternate parking lot location for the market. As a license agreement, it is revocable at will should the city need the lot for another purpose. Additionally, either party may terminate the agreement with thirty-day notice.

Currently, the market charges vendors a seasonal fee of \$150 per space and a single market fee of \$25 per space. The market vendors that are selling produce they have grown are exempt from local business licensing requirements. All other vendors are required to have a Columbia business license to sell.
