Re: Authorizing a sponsorship agreement with the Columbia Art League for the 2025 Art in

the Park event

#### **Executive Summary**

This resolution would authorize an agreement for the use of \$10,000 in Tourism Development funds for the Art in the Park festival to be held June 7 & 8 2025 at Stephens Lake Park.

#### Discussion

The Columbia Art League has submitted a Tourism Development application to the Convention & Visitors Bureau (CVB), requesting funding for the 2025 Art in the Park festival.

Art in the Park, a premier fine arts and crafts festival, will take place on June 7–8, 2025, at Stephens Lake Park. Held annually for over 60 years, the festival showcases approximately 110 artists from across the state and region. In addition to the art exhibition, the event features food trucks, live music, and entertainers. Last year, it attracted approximately 18,000 attendees.

The festival contributes to the local economy and reinforces Columbia's reputation as an arts tourism destination. The Convention & Visitors Bureau Advisory Board reviewed the application at its February 24, 2025, meeting and voted to recommend awarding \$10,000 in Tourism Development funds. These funds would support regional and national advertising, as well as printing costs.
