Re: Approving amendments to the Memorandum of Agreement between the City and the

Columbia Police Lieutenants Association (CPLA) for certain base pay adjustments.

### **Executive Summary**

The City of Columbia has negotiated an amendment to the Memorandum of Agreement with the Columbia Police Lieutenants' Association, (CPLA) for the following pay adjustments: Effective September 15, 2024, minimum starting pay for Police Lieutenant shall be \$49.67 per hour.

Effective September 15, 2024, Current Police Lieutenants shall be assigned the following hourly rates:

- \$50.66: Lieutenants Gremore, Kaneaster, Muscato, and Sedgwick
- \$51.65: Lieutenants Alpers, Horrell, Sinclair
- \$52.64: Lieutenant Gooch

The amendment requires City Council approval.

#### Discussion

The City of Columbia Code of Ordinance, Section 19-25 establishes the roles and responsibility for labor negotiations; it sets out the process for those negotiations and includes a timeline. The city council, as a council or as individuals, are prohibited from engaging in any form of collective bargaining with employees, employee groups, or employee representatives. The city council is required to issue instructions on labor relations matters and working agreement provisions only to the city manager. The city manager, in turn, is required to keep the council informed of all developments and potential impacts in a timely manner.

Since April, City of Columbia management and representatives for Columbia Police Lieutenants' Association, (CPLA) have been negotiating the FY24 and FY25 pay adjustments. The proposed amendment is the result of many hours of hard work and compromise from both sides.

### Fiscal Impact

Short-Term Impact: All costs associated with implementation of the pay proposal have been included in the current and proposed FY 2025 Budget.

Long-Term Impact: Based on annual budget and collective bargaining process.
