Re: Authorizing a Special Event Operations Agreement with Ragtag Film Society for the 2026 True False Film Fest.

Executive Summary

The Ragtag Film Society has submitted a special events application for the 2026 True/False Film Fest, March 5 through March 9, 2026 in downtown Columbia. This resolution authorizes the Operations Agreement pursuant to Section 24-73(b) of the City Code.

Discussion

The City Special Events Committee has reviewed the Special Event Application for the 2026 True/False Film Fest and worked closely with Ragtag Film Society to address all aspects of the event. Staff has reviewed the festival layout, street closure map, temporary art installations, public safety plan, solid waste plan and insurance requirements. Because of the size and scope of the True/False Film Fest and because it requires a street closure, includes a parade and requires city services and equipment, an operations agreement must be executed and approved by the City Council, per Section 24-73(b) of the City Code.

The Special Events Committee will continue to work with the festival organizers prior to the start of the event, including a walk-through inspection with the public safety team to ensure all aspects of the Operations Agreement are met and approved by appropriate city staff.
