To be clear, speed signs alone will not slow traffic but should nevertheless be posted & visible, in addition to implementing interventions such as speed bumps. The only sign on Hulen at present is obscured by trees and posted too late (at foot of hill) to have any effect. Even better: devices that show drivers their speed as compared with the posted limit. Drivers are bypassing the school zone on Fairview and feel they can speed on Hulen with impunity.

A "non motorized shared path" (bikers and walkers??!!) as suggested here would be neither practical nor safe. Better to add sidewalks where there are none!

I personally do not think more speed signs would slow drivers down. I think more significant traffic calming devices such as narrowing lanes by adding non-motorized shared path to 1 side of the street with physical barriers. Yes, this would reduce street parking, but would be most effective and give non-motorized users a safe lane of travel (possibly a convenient way to Fairview Rd. sidewalks for students.) Speed bumps could be an option, but drivers tend to speed more between bumps. Rollins Rd, is currently a sharrow (shared right of way for cyclist) and could be upgraded to include a dedicated shared use path narrowing motorized use lanes and calm traffic.

**Calm the traffic near Fairview and Rollins, and the traffic on Hulen should decrease.**

Calm the traffic near Fairview and Rollins, and the traffic on Hulen will decrease. Retrofit the sidewalk at the roundabout by cutting it back to match the sidewalks on the rest of the street, and wrap the school

pickup line around Yorktown drive so that traffic doesn't end up stopping in the roundabout, essentially blocking all cars from even going through. This happens around 3:15/3:20 every weekday. Motorists are forced to detour around the traffic using Hulen. The roundabout at Fairview and Rollins is too small to work properly. Cars actually speed up while approaching it, as if whoever gets there first gets to blast through it. And the sidewalk just south of the roundabout sticks out ridiculously far into the road, creating a dangerous bottleneck at school pick up times. It is impossible for through traffic to pass through the roundabout, or to bypass the pick up line, without driving over the center median. I would recommend solving this problem first; and then see if Hulen traffic is naturally more calm.



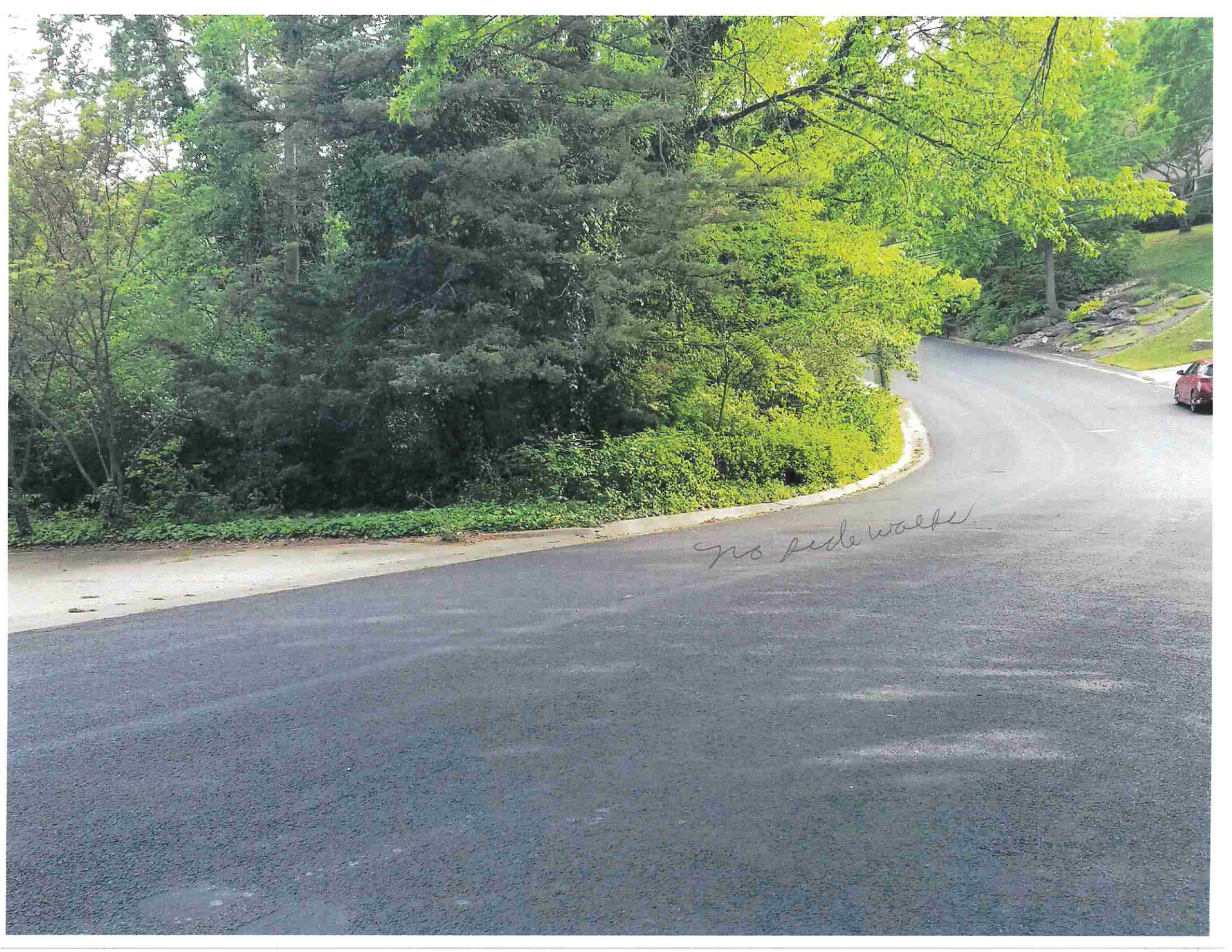
