## **Executive Summary**

Authorizing the City Manager to execute a professional engineering services agreement with Crawford, Murphy & Tilly Inc. for services relating to a comprehensive review and modification of the City's current complete street policy. The engineering services agreement is for a not to exceed amount of \$340,110.00.

#### Discussion

Crawford, Murphy & Tilly Inc. (CMT) has been chosen through the competitive request for qualifications process to provide engineering expertise to complete a comprehensive review of the City's current complete street policy; to draft modifications to the policy, and to draft modifications to the City's development ordinances. This work is being completed by a FY2022 Safe Streets for All grant through the U.S. Department of Transportation that has been awarded to the City.

The Consultant will provide engineering expertise to complete a comprehensive review of the City's complete street policy which was originally adopted in 2004; and draft revisions to the policy and to the City development ordinances. The review shall consider all modes of transportation. The Consultant will provide public engagement with the community, the City's applicable Boards and Commissions, and the City Council members in order to incorporate a variety of viewpoints and voices to addresses the vision of the City as a whole. This vision shall then be incorporated into the policy and ordinance revisions.

The engineering scope of services includes the following tasks:

- Project administration;
- Community relations;
- Stakeholder engagement;
- Existing policy review and scoring;
- National best practice research;
- Draft complete streets policy; and
- Final complete streets policy.

The professional engineering services agreement is for a not to exceed amount of \$340,110.00. This project is funded by the FY2022 Safe Streets for All grant through the U.S. Department of Transportation. The grant will fund 80% of the project. The City's 20% match will be funded by the ½-cent Capital Improvement Program sales tax or other eligible sources.
