Re: Amending a funding agreement with Moberly Area Community College for workforce development scholarships, training programs and facilities.

## Executive Summary

Authorize the City Manager to execute an amended funding agreement with Moberly Area Community College to include the new workforce development program "Aviation Flight Technology".

## Discussion

The Moberly Area Community College (MACC) has requested an amendment to the current Workforce Development partnership with the City of Columbia as entered into in March 2022. MACC has experienced some challenges in generating the specific activity as anticipated in the original agreement. As a result they would like to propose a decrease in two areas, with the addition of a new area of workforce development activity to better utilize the funds.

It appears MACC will not be able to fully utilize the funds in the area of CPS early college student scholarships and scholarship funds for the Makerspace. They are requesting a revision to their proposal to use funds for their new workforce program "Aviation Flight Technology" that will be located at the Columbia Regional Airport. MACC is proposing the use of funds for start-up costs that include: salary for the program director, as well as funding for the aviation contracted instruction costs with a maximum amount not to exceed of \$230,000.

This change still meets the Missouri Department of Higher Education and Workforce Development (MDHEWD) "Workforce Demand Justification" which states "This will be used to justify projects through which people will be trained/educated to enter occupations that were especially impacted by COVID-19 and/or the resulting economic and educational disruptions."
