#### I. INTRODUCTORY ITEMS

The City Council of the City of Columbia, Missouri met for a regular meeting at 7:00 p.m. on Tuesday, September 3, 2024, in the Council Chamber of the City of Columbia, Missouri. The Pledge of Allegiance was recited, and the roll was taken with the following results: Council Member VALERIE CARROLL, Council Member LISA E.A. MEYER, Council Member ROY LOVELADY, Council Member NICK FOSTER, Council Member BETSY PETERS (arrived at approximately 7:02 p.m.), and Mayor BARBARA BUFFALOE were present. Council Member DON WATERMAN was absent. City Manager De'Carlton Seewood, City Counselor Nancy Thompson, City Clerk Sheela Amin, and various Department Heads and staff members were also present.

The minutes of the regular meeting of August 19, 2024 were approved unanimously by voice vote on a motion by Mayor Buffaloe and a second by Council Member Foster.

Upon her request, Mayor Buffaloe made a motion for Council Member Carroll to be allowed to abstain from voting on B203-24. Council Member Carroll noted on the Disclosure of Interest form that her husband's employer has a financial responsibility for the Frank Morris Trust, which is providing funding for the bike park construction project. The motion was seconded by Council Member Meyer and approved unanimously by voice vote.

Mayor Buffaloe noted a citizen had asked for R156-24 to be moved from the consent agenda.

The agenda, as amended, including the consent agenda with R156-24 being moved to new business, was approved unanimously by voice vote on a motion by Mayor Buffaloe and a second by Council Member Lovelady.

The public hearing was read by the City Clerk, and B179-24 was given third reading by the City Clerk.

Finance Director Matthew Lue and Budget Officer Andrea Greer provided a staff report, and they along with Assistant Finance Director Jim McDonald, City Manager De'Carlton Seewood and Police Chief Jill Schlude responded to Council questions and comments.

Mayor Buffaloe opened the public hearing.

John Conway, 4902 Thornbrook Ridge, spoke.

Eugene Elkin, 3406 Range Line Street, spoke.

Chriss Jones, a Second Ward resident, spoke on behalf of Hold CoMo Accountable.

Troy Sapp spoke.

There being no further comment, Mayor Buffaloe closed the public hearing.

**Mayor Buffaloe made a motion to amend Exhibit A of B179-24 by approving staff amendments No. 1 through No. 44. The motion was seconded by Council Member Lovelady and approved unanimously by voice vote.**

**Mayor Buffaloe made a motion to amend Exhibit A of B179-24 by approving council amendment No. 1. The motion was seconded by Council Member Meyer and approved unanimously by voice vote.**

**Council Member Meyer made a motion to amend Exhibit A of B179-24 by approving council amendment No. 2. The motion was seconded by Mayor Buffaloe. After discussion, the motion was approved unanimously by voice vote.**

**Mayor Buffaloe made a motion to amend Exhibit A of B179-24 by approving council amendment No. 3. The motion was seconded by Council Member Foster and approved unanimously by voice vote.**

Mayor Buffaloe made a motion to amend Exhibit A of B179-24 by approving council amendment No. 4. The motion was seconded by Council Member Meyer. After discussion, the motion was defeated unanimously by voice vote.

Mayor Buffaloe explained the budget with these amendments would be voted on at the next council meeting.

PH31-24 Proposed addition of one (1) new 69 kV bus at the Bolstad Substation to provide for generation interconnection to the Boone Stephens solar facility.

The public hearing was read by the City Clerk.

Utilities Director David Sorrell provided a staff report.

Mayor Buffaloe opened the public hearing.

There being no comment, Mayor Buffaloe closed the public hearing.

**Mayor Buffaloe made a motion to authorize staff to proceed with the final design for a new 69 kV bus for the interconnection of the Boone Stephens solar facilities at the Bolstad Electric Substation. The motion was seconded by Council Member Meyer and approved unanimously by voice vote.**

**VI. OLD BUSINESS**

B192-24 Amending Chapter 21 of the City Code relating to duties and responsibilities of the Citizens Police Review Board.

The bill was given second reading by the City Clerk.

City Counselor Nancy Thompson provided a staff report, and responded to Council questions.

David Tyson Smith with offices on Cherry Street in Columbia and in Jefferson City spoke.

Chriss Jones, a Second Ward resident, spoke.

Doug Hunt, a Fourth Ward resident and Chair of the Citizens Police Review Board, spoke.

The Council asked questions and made comments.

Council Member Foster made a motion to table B192-24 to the November 4, 2024 Council Meeting and to suspend the activities of the Citizens Police Review Board related to hosting public meetings and educational programs as well as policy review. The motion was seconded by Council Member Lovelady. After discussion, the motion was defeated by roll call vote with Council Member Carroll, Council Member Lovelady, and Council Member Foster voting yes, and Council Member Meyer, Council Member Peters, and Mayor Buffalo voting no.

The Council asked additional questions and made comments.

**B192-24 was given third reading by the City Clerk with the vote recorded as follows: VOTING YES: CARROLL, MEYER, PETERS, BUFFALOE. VOTING NO: LOVELADY, FOSTER. ABSENT: WATERMAN. Bill declared enacted, reading as follows:**

B209-24 Authorizing a cooperative agreement with Boone County, Missouri for a comprehensive study to identify housing needs across various demographic segments, evaluate existing housing stock, and recommend strategic solutions and policy frameworks.

The bill was given second reading by the City Clerk.

Housing and Neighborhood Services Director Becky Thompson provided a staff report, and responded to Council questions and comments.

The Council made comments.

**B209-24 was given third reading by the City Clerk with the vote recorded as follows: VOTING YES: CARROLL, MEYER, LOVELADY, FOSTER, PETERS, BUFFALOE. VOTING NO: NO ONE. ABSENT: WATERMAN. Bill declared enacted, reading as follows:**

Public Works Director Shane Creech provided a staff report, and responded to Council questions.

Chriss Jones, a Second Ward resident, spoke.

Eric Westhues of Westhues Architecture spoke as the representative of Jonkman Construction and Commerce Bank.

The Council asked questions and made comments.

**R156-24 was read by the City Clerk, and the vote was recorded as follows: VOTING YES: CARROLL, MEYER, LOVELADY, FOSTER, PETERS, BUFFALOE. VOTING NO: NO ONE. ABSENT: WATERMAN. Resolution declared adopted, reading as follows:**

## IX. INTRODUCTION AND FIRST READING

## XI. GENERAL COMMENTS BY PUBLIC, COUNCIL AND STAFF

Traci Wilson-Kleekamp spoke regarding the Citizens Police Review Board (CPRB), the State Legislature, SB26, and the need to take the uncomfortable vote at times.

Eugene Elkin, 3406 Range Line Street, spoke about the danger of fluoride and other additives to the water.

Chriss Jones, a Second Ward resident, spoke about the need to engage with and better inform residents of services available, especially those most in need.

Troy Sapp spoke regarding the use of drones at parks instead of adding more park rangers, the need to study the reason for the increase in the number of homeless being hit by cars, and the handling of the homeless by the police.

The Council and staff discussed various topics to include appreciation for labor unions in honor of Labor Day as well as concerns associated with definition of family and its tie to occupancy limits.

**Council Member Carroll made a motion for the Planning and Zoning Commission to evaluate alternate mechanisms to calculate occupancy limits. The motion was seconded by Council Member Meyer. After discussion, the motion was approved unanimously by voice vote.**

The Council and staff continued discussing various topics to include the Neighborhood Watch program, a reminder to talk to one's neighbors, the status of Flock, the status of the staffing within the Police Department, appreciation for Troy Sapp telling his story to the City Council, the approval of ARPA contracts via the consent agenda, the upcoming Black Business Expo hosted by Columbia College, approval of the first conditional use permit for a short-term rental via the consent agenda, appreciation to have been able to participate in a solid waste ridealong as it had been educational, appreciation for the work of city staff, the Boone County Nature School, the True North Men as Allies Breakfast, which was a fundraiser to assist with issues related to domestic violence, the Girls State documentary, which revealed the inequities women continue to face, Council Member Foster's intent to be an ally to his fellow women council members, inequities in the treatment of women in leadership versus men in leadership, and sidewalk continuity.

**Mayor Buffaloe made a motion for staff to provide a report with options to maintain sidewalk continuity, especially during construction in the downtown area. The motion was seconded by Council Member Carroll and approved unanimously by voice vote.**

The Council and staff continued discussing various topics to include the increase in funding to some of their priorities, such as social services, housing, etc., the support for low-income housing tax credits on the consent agenda for two projects to help with affordable housing, staffing per capita within the Police Department, the hope that the Citizens Police Review Board can continue to do its work along with the hope that the State Legislature corrects the unintended consequences of SB754, and the importance of media literacy.
