Re: First Quarter Budget Adjustments

## Executive Summary

For FY 24 budget adjustment requests will be compiled by Finance and brought to City Council for consideration on a quarterly basis. For the first quarter, adjustments are requested by Cultural Affairs, Community Development, Police, Electric, Public Health & Human Services, Information Technology, Facilities Management, Parks & Recreation, Water CIP, Public Works CIP, Other General Government CIP, Fire CIP, and Parks & Recreation CIP.

## Discussion

### Operating:

#### **Cultural Affairs: \$15,671.23**

The 2023 Celebration of the Arts was held on Aug. 23, 2023 with the intent that the net proceeds would be transferred to the Columbia Arts Fund at the Community Foundation of Central Missouri. This action is consistent with past appropriations following the Celebration of the Arts event.

#### **Community Development: \$1,163,946.09**

This is to appropriate the unused funds remaining from the original \$1.82M that was appropriated in FY 22 for workforce development programs.

#### **Police: \$101,000**

Requesting an appropriation of **\$36,000** from the Police Training Fund to the Police Operating Budget to send three members of Command Staff to Senior Management Institute for Police (SMIP) training this coming spring/summer. Historically, the police department uses the Police Training Fund to send one or two members of command staff to this upper-level police management training. Due to COVID, staff have not been sent and we are requesting to send three command staff members this year to catch back up.

Requesting an appropriation of **\$65,000** for a one-time increase to fund an increase in Police Academy Expense for FY 24. Historically, the department budgets to send 9 applicants per year at \$5,000 per applicant. Due to the increased number of officer vacancies, the department anticipates sending 22 applicants to the academy in FY 24. This was originally requested and approved as an FY 24 NDI, however it did not get added to the FY 24 Approved Budget Document.

## **Electric: \$165,000**

Due to cost increases for the contractor to perform the required major maintenance on the landfill gas generator units, staff is requesting \$165,000 in additional funds. Performing major maintenance on existing infrastructure extends the useful life and defers any major repairs that may occur from not properly maintaining the equipment.

## **Public Health & Human Services: \$122,480**

Requesting an appropriation of **\$6,431** due to an increase in the medical liability insurance premium for 2024 over what was budgeted.

Requesting an appropriation of **\$5,479** for the annual disbursement amount from the Conley Fund. These funds must be used to meet the unmet needs of "the poor" of Columbia and will be used to supplement the Public Health & Human Services department's human services programs.

Requesting an appropriation of **\$110,570** for the HIV Case Management grant that was originally appropriated mid-year FY 23 and was inadvertently left out of the FY 24 budget.

## **Information Technology: \$56,795**

Requesting an appropriation of **\$56,795** for implementation of OpenGov budget software that was originally budgeted in FY 23, but was not spent until FY 24.

## **Facilities Management: \$432,000**

Requesting an appropriation of **\$432,000** to cover the costs for utilities and maintenance of the Lemone building until a buyer is found.

## **Parks & Recreation: \$6,603**

Requesting an appropriation of **\$6,603** to account for FY 23 transactions posted to FY 24 in error.

## **Capital Projects:**

### **Water CIP: \$279,480**

This request would appropriate \$279,480 from various completed Water capital improvement projects to the Nebraska Stormwater Incidental Water Relocation project. This project is needed to relocate the water main due to the Nebraska Avenue Stormwater utility project that is receiving ARPA funding from DNR.

### **Public Works CIP: \$2,221,023.44**

Appropriation of grant funds to the following projects:
