## AN ORDINANCE

extending the corporate limits of the City of Columbia, Missouri, by annexing property located north of Gibbs Road (3705 W. Gibbs Road); directing the City Clerk to give notice of the annexation; placing the property annexed in R-1 (Onefamily Dwelling), R-2 (Two-family Dwelling), and R-MF (Multiple-family Dwelling) zoning districts; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby finds that a verified petition was filed with the City on November 21, 2023, requesting the annexation of land which is contiguous and compact to the existing corporate limits of the City and which is described in Section 4 of this ordinance. The petition was signed by a representative from the Roxie Grant Revocable Trust, the sole owner of the fee interest of record in the land proposed to be annexed. A public hearing was held concerning this matter on December 18, 2023. Notice of this hearing was published more than seven (7) days prior to the hearing in a newspaper of general circulation qualified to publish legal matters. At the public hearing all interested persons, corporations and political subdivisions were permitted to present evidence regarding the proposed annexation.

SECTION 2. The Council determines that the annexation is reasonable and necessary to the proper development of the City and that the City has the ability to furnish normal municipal services to the area to be annexed within a reasonable time.

SECTION 3. The Council determines that although a protest petition was filed with regard to the proposed zoning of the property no written objection to the proposed annexation has been filed within fourteen days after the public hearing.

SECTION 4. The City Council hereby extends the city limits by annexing the land described in Section 1-11.\_\_ [number to be assigned by the City Clerk] of the Code of Ordinances of the City of Columbia, Missouri, which is hereby added to Chapter 1 of the City Code and which reads as follows:

Section 1-11.\_\_ [number to be assigned by the City Clerk]. January, 2024 Extension of Corporate Limits.

The corporate limits of the City of Columbia shall include the following land:

The City Clerk is further authorized and directed to forward to the Missouri Department of Revenue, by registered or certified mail, a certified copy of this ordinance and a map of the City clearly showing the area annexed to the City.
