



ADDENDUM OF SERVICES AGREEMENT

City of Columbia, MO

This is the THIRD Addendum by and between **RECTRAC, LLC d/b/a VERMONT SYSTEMS**, a Delaware limited liability company having its principal address at 12 Market Place, Essex Junction, VT 05452 (“VS,” “Licensor,” “we,” “our,” or “us”) and **City of Columbia, Missouri** having its principal address at 701 E. Broadway, Columbia, MO 65201 (“Customer,” “Licensee,” “you” or “your”) and (each a “Party,” and, collectively, the “Parties”), is effective as of the date of the last signature below.

WHEREAS, on 06/10/2021 VS and Customer entered into a Software as a Service Agreement, later modified by Addendum One dated January 17, 2024 and Addendum Two dated August 19, 2025 (the “Agreement”); and

WHEREAS, the Parties desire to amend the Agreement to remove the **WebTrac App** from the services effective retroactive to August 19, 2025, the effective date of the WebTrac App Addendum.

NOW, THEREFORE, for and in consideration of the mutual covenants herein contained, the Parties agree to amend the Agreement as follows: the WebTrac App is no longer part of the products/services received or paid for. Any fees paid by the City of Columbia, Missouri to VS for the WebTrac App, including any setup and services fees, shall be refunded to the City within thirty (30) days of the effective date of this THIRD Addendum.

All other terms and conditions of the Agreement shall remain in full force and effect.

ACCEPTANCE

Customer acknowledges that it has read, understands and accepts this Amendment as written, inclusive of all attachments, schedules or exhibits, as may be revised, and agrees to pay all Fees and all other charges permitted by the Agreement and this Amendment. The individual signing the Agreement on behalf of Customer acknowledges that he/she has the proper legal authority to act on the Customer’s behalf and to bind the Customer to this Amendment.
