The total the campaign has raised in all of its six years is \$2,727,000

Connecting donors to the community needs they care about. Some of CFCM's impact can be seen in central Missouri nonprofit capital projects. The new Columbia Agriculture Park, Clary-Shy, has received over \$712,000 from CFCM funds in 2018; the project is slated for dedication in 2019. The Central Missouri Cancer Memorial Park received over \$39,600 in 2018 and was dedicated in October 2018. And the new Boonville Animal Shelter received donations of over \$28,500 in 2018, all coming from local citizens for a project to be completed in 2019.
