The committee also discussed increased tax revenue from Sales Tax, Gasoline Tax, and Park Tax. Lue clarified that some revenue was committed to Public Safety, Streets, and Transit.

Suhler asked about the status of the Pay and Compensation Study. Lue responded it was not yet completed.

Suhler asked if the pay increase for Transit could be addressed before the Study is received. Lue responded that revenue from ridership is not where it needs to be in order to increase salaries at this time. Bloom asked if the city had any data on why ridership hasn't kept up. Lue said there is no data, only narrative.
