I attended the city meeting the other day about Northland road and some of the neighbors suggestions seem.... unfeasible. I also do not agree that people are speeding in excess of 50mph regularly. If there are over 1,000 cars per day with drag races surely there would be more accidents? Its primarily residential traffic and we are all aware of the deer and other smaller animals, or dogs on that street.

Some of the neighbors suggested widening the road. That makes sense since seeing how we are in town now ( development speaking) and there is no sidewalk, nor immediate plans for one.

But about the speed: I also noticed the speed limit sign (coming onto northland from Blueridge) is right when you go up the hill and none of us even look at it bc we are more concerned with cars coming over the hill at us. Maybe if they moved the speed limit sign up to the top of the hill where the "straight away" is it would be more noticeable to traffic.

I had previously suggested a center strip which the road may be too narrow for, but wouldn't it be beneficial to add a yellow stripe down the shoulder too?

There have been traffic studies that show adding a small pop out in traffic tunnels helps to reduce drivers' speed. I wonder if adding a yellow line down the sides as well as center would help to slow drivers in a similar way. It would also help drivers find the edge of the road a little better.

Anyways hope this is useful.

Oh, the neighbor also brought up safety concerns regarding a speed hump on the top of the Northland hill: if there is a speed hump on the top of the hill how will that effect our snow driving? Will drivers be able to make it up the hill safely with a speed hump and a steep ditch on either side?
