Re: Authorizing construction and improvement of public storm drainage infrastructure on Sexton Road and McBaine Avenue; calling for bids through the Purchasing Division or authorizing a contract for the work using a term and supply contractor.

Executive Summary

Staff has prepared for council consideration an ordinance authorizing construction and issuing a contract for the work, or a bid call through the Purchasing Division, for the replacement and improvement of public storm drainage infrastructure on Sexton Road and McBaine Avenue. The project location is shown on the attached map. The public hearing for this project was held on November 6, 2023. The cost estimate for this project is \$640,000 and will be paid from Stormwater Utility funds.

Discussion

The Sexton Road and McBaine Avenue Stormwater Improvement Project will include replacement and improvement of public storm drainage infrastructure on Sexton Road, McBaine Avenue and Jefferson Street, as shown on the Project Graphic. It will consist of constructing approximately 614 feet of new stormwater pipe and eight (8) stormwater structures. The existing stormwater system in this area is undersized and in poor condition, causing roadway flooding. Portions of the existing stormwater system along Sexton Road will be abandoned and the proposed stormwater pipes will be rerouted towards the south into an existing box culvert.

Staff anticipates that this construction project will be bid out by the Purchasing Division. However, this ordinance authorizes construction either through the City's term and supply contracts or by bidding through Purchasing, whichever is most appropriate. Construction is expected to commence in 2025.

Fiscal Impact
