



Lot 201 Dell Jones Plat 2 Easement Vacation

A tract of land located in the southeast quarter of Section 20, Township 49 North, Range 12 West and the southwest quarter of Section 21, Township 49 North, Range 12 West in the City of Columbia, Boone County, Missouri being part of lot 201 of Dell Jones Plat 2 as recorded in Plat Book 39, Page 10 all being of the Boone County records and being more particularly described as follows:

Commencing at the northwest corner of said Lot 201 of Dell Jones Plat 2, recorded in Plat Book 39, Page 10, also being a point on the south right-of-way line of Waco Road as dedicated by said Dell Jones Plat 2; Thence east along said right-of-way line S 89°23'50"E, 10.44 feet to the point of beginning; Thence continuing along said south right-of-way line S 89°23'50"E, 754.72 feet; Thence leaving said south right-of-way line S 00°36'30"W, 10.00 feet; Thence N89°23'50"W, 757.73 feet; Thence N 17°20'20"E, 10.44 feet to the point of beginning and containing 7,562 square feet.

Bearings are referenced to grid north of the Missouri state plane coordinate system NAD83 (2011), epoch date 2010.00, central zone, by GPS observations, using MoDOT VRS network.



Lot 202 Dell Jones Plat 2 Easement Vacation

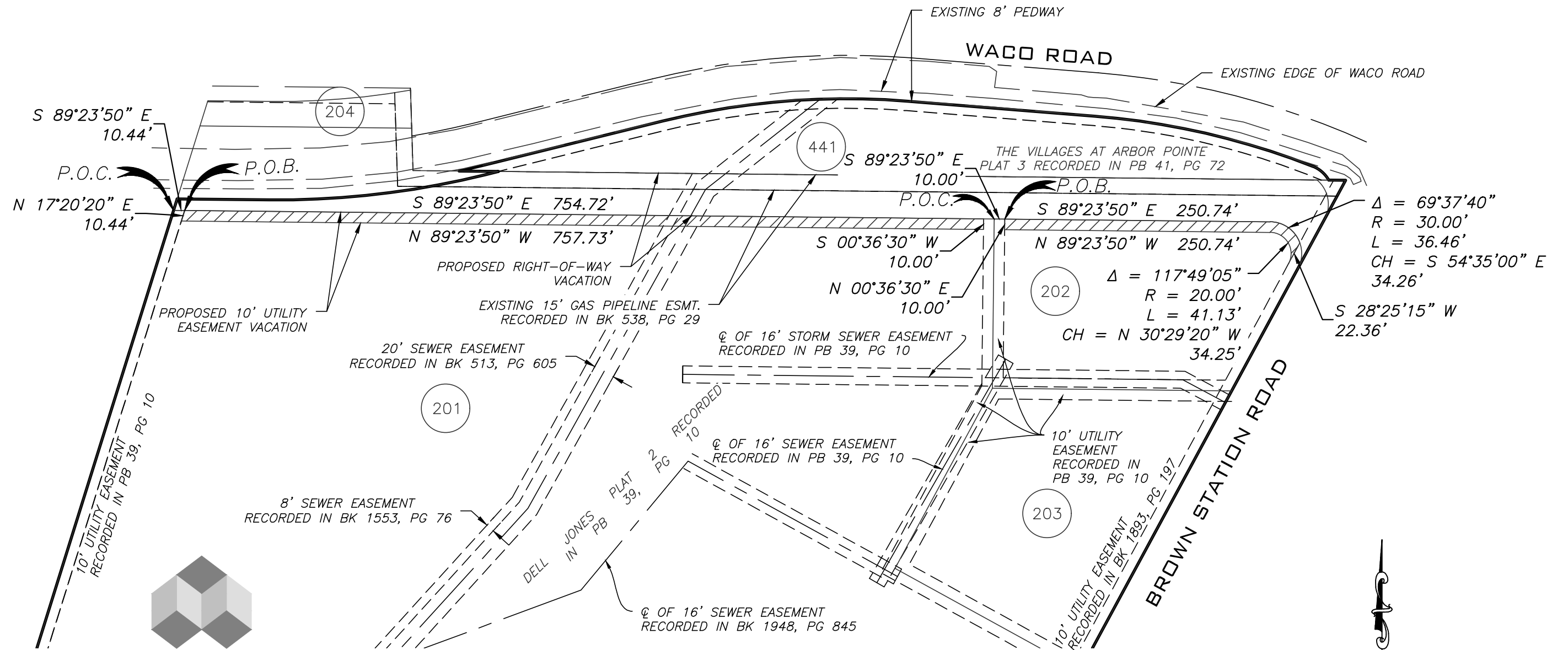
A tract of land located in the southwest quarter of Section 21, Township 49 North, Range 12 West in the City of Columbia, Boone County, Missouri being part of lot 202 of Dell Jones Plat 2 as recorded in Plat Book 39, Page 10 all being of the Boone County records and being more particularly described as follows:

Commencing at the northwest corner of said Lot 202 of Dell Jones Plat 2, recorded in Plat Book 39, Page 10, also being a point on the south right-of-way line of Waco Road as dedicated by said Dell Jones Plat 2; Thence east along said right-of-way line S 89°23'50"E, 10.00 feet to the Point of Beginning; Thence continuing along said south right-of-way line S 89°23'50"E, 250.74 feet; Thence along a tangent curve to the right having a radius of 30.00 feet and arc length of 36.46 feet, and said curve having a chord which bears S 54°35'00"E, 34.26 feet; Thence leaving said south right-of-way line S 28°25'15"W, 22.36 feet Thence along a non-tangent curve to the left having a radius of 20.00 feet, an arc length of 41.13 feet, and said curve having a chord which bears N 30°29'20"W, 34.25 feet; Thence N 89°23'50"W, 250.74 feet; thence N 00°36'30"E, 10.00 feet to the Point of Beginning and containing 2,867 square feet.

Bearings are referenced to grid north of the Missouri state plane coordinate system NAD83 (2011), epoch date 2010.00, central zone, by GPS observations, using MoDOT VRS network.
