Re: Authorize a fourth supplemental agreement to an airport aid agreement with the Missouri Highways and Transportation Commission (MHTC) relating to air service promotion

for the Columbia Regional Airport

## **Executive Summary**

Staff is requesting that Council authorize the City Manager to execute a fourth supplemental agreement to an airport aid agreement with MHTC relating to air service promotion for Columbia Regional Airport.

#### Discussion

On August 19, 2019, Council Bill 222-19 was passed authorizing the City Manager to execute an airport aid agreement with MHTC in the amount of \$250,000 relating to air service promotion for Columbia Regional Airport.

On July 6, 2020, Council Bill 128-20 was passed authorizing a first supplemental agreement to the airport aid agreement with MHTC to allow for \$150,000 of the original \$250,000 grant to be used specifically in support of marketing a new twice daily service to Charlotte, North Carolina with American Airlines. The first supplemental agreement also extended the project period to August 1, 2021. A second supplemental agreement approved by Council on August 16, 2021 extended the project period to August 1, 2022; and a third supplemental agreement approved by Council on August 15, 2022 extended the project period to August 1, 2023.

Staff is now requesting that Council authorize the City Manager to execute a fourth supplemental agreement with MHTC to extend the project period from August 1, 2023 to August 1, 2024, to allow staff time to continue to work toward securing new service. A request for Council to approve the amendment along with an explanation and request that all actions taken by city staff prior to execution of the amendment be ratified.
