Re: Aviation Project Consultant Supplemental Agreement No. 1 with Burns and McDonnell Engineering Company for Construction Services related to Runway 2-20 Pavement Repairs at Columbia Regional Airport.

Executive Summary

Staff is requesting that Council authorize the City Manager to execute an Aviation Project Consultant Supplemental Agreement No. 1 with Burns and McDonnell Engineering Company for construction services related to Runway 2-20 Pavement Repairs project at Columbia Regional Airport.

Discussion

The Runway 2-20 Pavement Repair project was authorized as part of the FY2024 annual budget to include pavement removal and replacement, spall repairs, joint sealant replacement and painting on Runway 2-20 of the south Taxiway A intersection; north of the Taxiway A1 intersection; and north of the Taxiway A2 intersection, at an estimated cost of \$2,567,565 for design and construction.

Resolution 176-23 was adopted on November 20, 2023, authorizing the City Manager to execute an agreement with Burns & McDonnell to provide design services related to this project in the amount of \$273,800. Staff is now requesting Council authorize the City Manager to execute Supplemental Agreement No. 1 with Burns & McDonnell for construction services in the amount of \$256,250. The FAA will reimburse the City for 90% of this cost.

Fiscal Impact

Short-Term Impact: The supplemental agreement No. 1 with Burns & McDonnell is for a not to exceed amount of \$256,250 and will be 90% reimbursed by the FAA. The City's 10% match will be paid from TST.
