

A RESOLUTION

authorizing the temporary closure of a portion of the sidewalk, parking lane, and vehicular lane shifting on Stewart Road between Fourth Street and Fifth Street, and a portion of the sidewalk on Fifth Street between Stewart Road and Elm Street to facilitate a roof removal and replacement at the University of Missouri power plant.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby authorizes SIRCAL Contracting, LLC (“SIRCAL”) the following temporary closures of sidewalks and parking lane, and vehicular lane shifting as shown on “Exhibit A” attached hereto, from March 9, 2026 through November 1, 2026 to facilitate a roof removal and replacement at the University of Missouri power plant:

**Stewart Road between Fourth Street and Fifth Street
March 9, 2026 through November 1, 2026**

- Closure of a portion of the sidewalk on the north side of Stewart Road
- Closure of the parking lane on the south side of Stewart Road
- Shifting of both vehicular lanes to the south side of Stewart Road

**Fifth Street between Stewart Road and Elm Street
March 9, 2026 through November 1, 2026**

- Closure of a portion of the sidewalk on the west side of Fifth Street

SECTION 2. SIRCAL shall close the sidewalk, parking lane, and shifting of vehicular lanes only in accordance with the traffic control plans submitted and approved by the City’s Director of Public Works, which plans shall meet or exceed the requirements of the Americans With Disabilities Act. In the interest of public safety, the Director of Public Works may require additional traffic control measures by notifying SIRCAL, in writing, of such requirements. SIRCAL shall be responsible for all signs and barricades necessary for the protection and convenience of the general public and shall be responsible for the repair of the sidewalk, parking lane, and vehicular lanes due to any damage caused by

the construction activity. SIRCAL shall be responsible for notifications to the media and emergency personnel.

SECTION 3. SIRCAL shall proceed with construction activities which require the temporary sidewalk, parking lane, and vehicular lane shifting without unnecessary delay so as to minimize disruption to the public. Failure to proceed without unnecessary delay may result in the revocation of the closure permit by the City Council.

SECTION 4. The temporary sidewalk and parking lane closure and vehicular lane shifting authorized herein may be terminated by the City Council upon recommendation of the Director of Public Works and a determination such closures are no longer necessary for the protection of the health, safety and welfare of the public or is otherwise in the best interest of the public.
