Re: Central Missouri Humane Society Contract for Services

Executive Summary

A resolution authorizing the City Manager to sign the 2024 Contract for Services between the City of Columbia and the Central Missouri Humane Society in the amount of \$222,762 effective January 1, 2024 through December 31, 2024.

Discussion

This agreement between the City of Columbia and the Central Missouri Humane Society (CMHS) provides for office space, kennel facilities, veterinary services and vaccinations for animals impounded by Animal Control. Boone County shares one-third of the cost for these services. All expenditures were budgeted in the FY24 budget. This contract reflects an increase in \$23,867 (12%) from the previous contract, which is due to an increase in the cost of animal care (food, supplies, kennel attendants, etc.).

Highlights of the agreement include:

\$2,500 – Office space, parking and reception services;

\$163,953 - Kennel facilities and care for impounded animals (25 kennels per day);

\$36,309 – Veterinary medical services, vaccinations and microchipping for impounded animals;

\$20,000 – Spay/neuter vouchers for 175 dogs and 150 cats with rabies vaccine for all cats and ear-tipping for all feral cats.
