Re: Accepting a full award of grants funds from the Missouri Department of Natural Resources for the stormwater pipe lining project; authorizing a financial assistance agreement; amending the FY 2024 Annual Budget by appropriating funds.

Executive Summary

Staff has prepared for Council consideration an ordinance authorizing acceptance of the full award of the stormwater pipe lining Stormwater Improvements Project in the amount of \$796,446.25 from the Missouri Department of Natural Resources for State Fiscal Recovery Funds under the American Rescue Plan Act (2021). This ordinance authorizes the Grants Administrator, Andrew Wyatt, to sign the grant agreement and the appropriation of grant funds to eligible projects.

Discussion

On June 6, 2022, Council passed Resolution 81-22 which authorized the Grants Administrator, Andrew Wyatt, to execute and file an application on behalf of the City of Columbia with the State of Missouri for American Rescue Plan Act Water Infrastructure Community Grant Programs through the Missouri Department of Natural Resources. The initial grant request was for drinking water, wastewater and stormwater infrastructure improvements. In November 2022, the Missouri Department of Natural Resources provided a notice of award for the following stormwater projects and funding amounts:

Stormwater Pipe Lining Award - #D614D92D0391:

Total request: \$1,008,159.81

Local cost share: \$ 211,713.56

Grant request: \$ 796,446.25

Once projects are bid, the MDNR provides funding agreements. A copy of the full award grant agreement for the stormwater pipe lining project is attached for review. This award specifically addresses the rehabilitation of deteriorated corrugated metal pipes associated

throughout the City. The total grant request and award amount is \$1,008,159.81, with the Federal contribution set at \$796,466.25 and the City match is \$211,713.56. The grant requires and 80/20 percent match. The City budgeted \$211,713.56 in the FY2024 Storm Water operating budget to account for the match portion of this grant. All construction must conclude by December 31, 2026, to qualify for reimbursement through the MDNR ARPA funds.

Fiscal Impact
