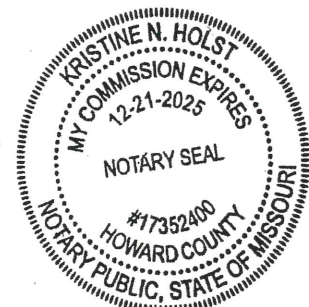

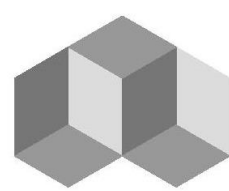

Beginning at the Southeast Quarter Corner of Section 14 as shown in the Land Corner Form Document #600-49553 and the survey recorded in Book 925, Page 463; Thence along the south line of said Section S 89°43'25"W, 2726.80 feet to the Southwest Quarter Corner of Section 14 as shown in the Land Corner Form Document #600-49552 and the survey recorded in Book 925, Page 463; Thence along the west line of the Southeast Quarter of Section 14, N 01°01'35"E, 1048.76 feet to the northwest corner of the survey recorded in Book 2617, Page 121; Thence leaving said west line of said Southeast Quarter, N 89°45'30"E, 2801.58 feet to the northeast corner of said survey; Thence leaving the north line S 00°00'55"E, 1013.24 feet; Thence S 60°59'10"W, 69.74 feet; Thence S 89°43'25"W, 32.85 feet to the Point of Beginning and containing 67.59 acres.
