#### **Executive Summary**

This resolution would authorize an agreement for \$10,000 in Tourism Development funds to assist with promotions & marketing and a portion of artist's fees of the 2024 "We Always Swing" Jazz Series.

#### Discussion

The "We Always Swing" Jazz Series started in 1995 and has become one of the very few and well-respected community-based jazz organizations in the Midwest. The 2023-2024 season will include two Grammy-award winning artists Maria Schneider Orchestra and Arturo O'Farrill Quintet. In addition "Jazz Appreciation Month" will be celebrated during the month of April. Several events are being co-planned with other local jazz entities and the local schools to raise awareness of jazz in general and increase Columbia's national profile as a significant jazz-friendly city.

Jon Poses, Executive Director of "We Always Swing, Inc." presented a Tourism Development Signature Series application to the Convention & Visitors Bureau Advisory Board on October 30, 2023 requesting tourism development funds for the 2024 series. The CVB Board reviewed & discussed the application and voted unanimously to recommend \$10,000 in tourism development funds to assist with promotions & marketing as well as a portion of artist's fees.
