#### PURCHASE AGREEMENT Between ELLIOTT EQUIPMENT COMPANY And CITY OF COLUMBIA, MISSOURI For TWO SIDE LOADING COLLECTION TRUCKS

THIS PURCHASE AGREEMENT (hereinafter "Agreement") is by and between the City of Columbia, Missouri (hereinafter "City" or "Buyer"), a municipal corporation whose address is 701 E. Broadway, Columbia, MO 65201 and Elliott Equipment Company, DBA Elliott Sanitation Equipment Company (hereinafter "Seller"), a corporation with the authority to transact business within the State of Missouri and whose address is 14219 Norby Road, Grandview, MO 64030, and is entered into on the date of the last signatory below (hereinafter "Effective Date"). City and Seller are each individually referred to herein as a "Party" and collectively as the "Parties."

WHEREAS, City has a need to purchase Side Loading Collection Trucks to provide solid waste collection services to City's customers;

WHEREAS, Seller has two (2) Side Loading Collection Trucks available for immediate purchase by City; and

WHEREAS, City wishes to purchase, and Seller wishes to sell two (2) Side Loading Collection Trucks pursuant to the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants set out in this Agreement and for other good and valuable consideration, the Parties agree as follows:

1. SIDE LOADING COLLECTION TRUCKS

"Side Loading Collection Truck" or "Truck" shall mean new 2024 Peterbilt 520, right hand drive only, Paccar PX-9 370HP diesel, Allison 4500 RDS automatic transmission, tandem axel, New Way Sidewinder 31 cu yd automated side loader, frame mounted arm with 1,000lb capacity and 12' reach, triple camera system with 7" color monitor, work lights, and strobe lights; and includes 5 year/150,000 mile extended warranty on the engine, transmission, aftertreatment system Peterbilt chassis, and towing; as provided in Seller's Quote dated April 1, 2024, attached hereto and incorporated herein as Exhibit A.

#### 2. SELLER REPONSIBILITIES

2.1. **Provision of Trucks**. Seller agrees sell to City two (2) Side Loading Collection Trucks as provided in this Agreement and in Exhibit A.

- 2.2. **Pricing.** Prices for the Side Loading Collection Trucks are set by the Seller's quote in Exhibit A at three hundred ninety six thousand nine hundred twenty one dollars (\$396,921.00) for each Truck for a total cost, including listed warranties, of seven hundred ninety three thousand eight hundred forty two dollars (\$793,842.00). Such pricing shall be paid by City as provided in Exhibit A.
- 2.3. **Warranty**. Seller shall provide warranties on the Side Loading Collection Trucks as provided in this Agreement and Exhibit A, and as provided in Seller's warranty information attached hereto and incorporated herein as Exhibit B.
- 2.4. **Delivery.** Seller shall deliver the two (2) Side Loading Collection Trucks to 5700 Peabody Road, Columbia, MO 65202 within 10 days of execution of this agreement.

#### 3. CITY RESPONSIBILITIES

- 3.1. **Payments**. City shall make payment as provided in the Contract Documents.
- 3.2. Not to Exceed Amount. It is expressly understood by both Parties that the cumulative amount of payment from City to Seller for two (2) Side Loading Collection Trucks, including warranties specified herein, shall not exceed seven hundred ninety three thousand eight hundred forty two dollars (\$793,842.00).
- 4. TERMINATION
  - 4.1. **Termination for Default**. If either Party fails to perform its duties and obligations provided for herein, then that Party shall be in default. The non-defaulting Party may provide notice of the default in writing with the reasoning provided. If the default is not cured within ten (10) calendar days from receipt of the written notice of default, then the non-defaulting Party may terminate this Agreement in whole or in part for failure to perform by providing written notice of termination. The written notice of termination will be effective immediately upon its receipt. In such event, the defaulting Party shall be liable for all damages (including all costs and attorney's fees) arising out of or related to the default.
  - 4.2. **Termination for Convenience**. City may terminate this Agreement, in whole or in part, at any time by written notice to Seller when it is in City's best interest. This termination goes into effect upon Seller's receipt of written notice.
- 5. MISCELLANEOUS

- 5.1. **Hold Harmless Agreement**. To the fullest extent not prohibited by law, Seller shall indemnify and hold harmless City, its directors, officers, agents, and employees from and against all claims, damages, losses, and expenses (including but not limited to attorney's fees) arising by reason of any act or failure to act, negligent or otherwise of Seller, of any subcontractor (meaning anyone including but not limited to contractors having a contract with Seller or a subcontractor), or anyone directly or indirectly employed by Seller or by any subcontractor, or anyone for whose acts Seller or its subcontractor may be liable, in connection with providing the Side Loading Collection Trucks. This provision does not, however, require Seller to indemnify, hold harmless, or defend City from its own negligence.
- 5.2. No Waiver of Immunities. In no event shall the language of this Agreement constitute or be construed as a waiver or limitation for either Party's rights or defenses with regard to each Party's applicable sovereign, governmental, or official immunities and protections as provided by federal and state constitution or laws.
- 5.3. **Governing Law and Venue**. This Agreement shall be governed, interpreted, and enforced in accordance with the laws of the State of Missouri and/or the laws of the United States, as applicable. The venue for all litigation arising out of, or relating to this Contract, shall be in Boone County, Missouri, or the United States Western District of Missouri. The Parties hereto irrevocably agree to submit to the exclusive jurisdiction of such courts in the State of Missouri.
- 5.4. **Missouri Anti-Discrimination Against Israel Act.** To the extent required by Missouri Revised Statute Section 34.600, Seller certifies it is not currently engaged in and shall not, for the duration of this Agreement, engage in a boycott of goods or services from the State of Israel; companies doing business in or with Israel or authorized by, licensed by, or organized under the laws of the State of Israel; or persons or entities doing business in the State of Israel. If any provision of this paragraph, or the application of such provision to any person or circumstance, shall be held invalid, the remainder of this Agreement, or the application of such provision to persons or circumstances other than those as to which it is held invalid, shall not be affected thereby. This paragraph shall not apply to Agreements with a total potential value of less than one hundred thousand dollars (\$100,000) or to contractors with fewer than ten (10) employees.
- 5.5. **General Laws**. Seller shall comply with all other federal, state and local laws, rules, regulations and ordinances.
- 5.6. **Notices**. Any notice, demand, request, or communication required or authorized by this Agreement shall be delivered either by hand, facsimile, overnight courier or mailed by certified mail, return receipt request, with postage prepaid to:

Any notice required by this Agreement to be given in writing or that either City or Seller wishes to give to the other in writing shall be signed by or on behalf of the Party giving notice. The notice shall be deemed to have been completed when sent by certified or registered mail to the other Party at the address set forth herein, or delivered in person to said Party or their authorized representative.

- 5.7. **No Third-Party Beneficiary**. No provision of this Agreement is intended to nor shall it in any way inure to the benefit of any customer, property owner or any other third party, so as to constitute any such person a third-party beneficiary under this Agreement.
- 5.8. **Amendment**. No amendment, addition to, or modification of any provision hereof shall be binding upon the Parties, and neither Party shall be deemed to have waived any provision or any remedy available to it, unless such amendment, addition, modification or waiver is in writing and signed by a duly authorized officer or representative of the applicable Party or Parties.
- 5.9. **Contract Documents**. The Contract Documents include this Agreement and the following attachments and exhibits which are incorporated herein by reference:

- A Seller's Quote dated April 1, 2024
- B Seller's warranty information

In the event of a conflict between the terms of any Exhibit or Attachment and the terms of this Agreement, the terms of this Agreement control. In the event of a conflict between the terms of any Exhibit and any Attachment, the terms of the documents control in the order listed above.

5.10. **Entire Agreement**. This Agreement represents the entire and integrated agreement between the Parties relative to the contracted services herein. All previous or contemporaneous contracts, representations, promises and conditions relating to the contracted services herein are superseded.

This warranty applies to new PACCAR PX-9 engines sold and used in the United States <sup>1</sup> or Canada and operated in onhighway applications with one exception – there is different warranty coverage for engines used in the fire apparatus truck applications.

The PACCAR PX-9 engine is warranted directly to the first purchaser or first lessee by PACCAR.

#### **Base Engine Warranty**

This warranty covers any failures of the engine which result, under normal use and

service, from a defect in material or factory workmanship (warrantable failure). This coverage begins on the date of delivery and ends two years or 250,000 miles (400,000 kilometers) or 6,250 hours, whichever occurs first, after the date of delivery of the engine to the first purchaser or first lessee.

Engine aftertreatment components included in the PACCAR critical parts list (CPL) and marked with a PACCAR part number are covered under base engine warranty.

Additional coverage is outlined in *Emissions Warranty* on page 79.

## PACCAR and Owner Responsibilites

Description of responsibilities for PACCAR and the owner of a PACCAR Brand Engine.

#### PACCAR Responsibilities

PACCAR will pay for all parts and labor needed to repair the damage to the engine resulting from a warrantable failure.

PACCAR will pay for the lubricating oil, antifreeze, filter elements, belts, hoses, and other maintenance items that are not reusable due to the warrantable failure.

PACCAR will pay for reasonable labor costs for engine removal and reinstallation when necessary to repair a warrantable failure.

PACCAR will pay during the base engine warranty period of two years or 250,000 miles (400,000 kilometers) or 6,250 hours, whichever occurs first: reasonable costs for towing a vehicle disabled by a warrantable failure to the nearest authorized repair location. In lieu of the towing expense and

The owner is responsible for the cost of lubricating oil, antifreeze, filter elements and other maintenance items provided during warranty repairs unless such items are not reusable due to the warrantable failure. The owner is responsible for communication expenses, meals, lodging and similar costs incurred as a result of a warrantable failure.

The owner is responsible for non-engine repairs and for "downtime" expenses, cargo damage, fines, all applicable taxes, all business costs and other losses resulting from a warrantable failure.

The owner is responsible for non-engine repairs and for "downtime" expenses, cargo damage, fines, all applicable taxes, all business costs and other losses resulting from a warrantable failure.

Your sole and exclusive remedy against PACCAR and the selling dealer arising from your purchase and use of this engine is limited to the repair or replacement of "warrantable failures" at authorized United States and Canadian PACCAR engine dealers or an authorized Cummins Distributor, or an authorized PACCAR engine facility where applicable, subject to PACCAR's time, mileage, and hour limitations of the engine warranty. The maximum time, mileage and hour limitations of the engine warranty begin running on the date of delivery to the first purchaser or first lessee. The accrued time, mileage, or hours is calculated when the engine is brought into an authorized dealer for correction of warrantable failures.

Failures, other than those resulting from defects in material or factory workmanship, are not covered by this warranty. If the vehicle in which the engine is installed is registered in the state of California, a separate *California Emissions Control Warranty Statement* on page 81 also applies. See California Emissions Warranty.

#### **Replacement Parts**

The California Air Resources Board and PACCAR are pleased to explain the emission control system warranty on your 2017 - 2018 model year diesel engine. In California, new motor-vehicle engines must be designed, built, and equipped to meet the State's stringent anti-smog standards. PACCAR must warrant the emission control system on your diesel engine for the periods of time listed below provided there has been no abuse, neglect or improper maintenance of your diesel engine.

Your emission control system may include parts such as the fuel injection system and engine electronic control module. Also included may be hoses, connectors and other emission related assemblies.

If an emission-related part on your engine is found to have a defect in material or factory the part will be repaired or replaced by PACCAR. This is your emission control system defects warranty.

Emissions coverage for on-highway applications in the State of California

This emission control system warranty applies to diesel engines (hereafter, engines) certified with the California Air Resources Board beginning with the year 2013, marketed by PACCAR, and registered in California for use in onhighway applications.

#### Manufacturer's Warranty Coverage

This warranty coverage is provided for five years or 100,000 mi (160,000) km or 3,000 hours of engine operation, whichever first occurs from the date of delivery of the engine to the first purchaser or first lessee. Where a warrantable condition exists, PACCAR will repair your engine at no cost to you including diagnosis, parts and labor.

#### **Owner's Warranty Responsibilities**

As the engine owner, you are responsible for the performance of the required maintenance listed in your PACCAR operator's manual. You are responsible for presenting your engine to an authorized PACCAR engine dealer or an authorized Cummins Distributor as soon as a problem exists. The warranty repairs should be completed in a reasonable amount of time, not to exceed 30 days.

PACCAR recommends that you retain all receipts covering maintenance on your engine, but PACCAR cannot deny warranty solely for the lack of receipts or for the failure to ensure the performance of all scheduled maintenance.

As the engine owner, you should also be aware that PACCAR may deny you

warranty coverage if your engine or a part has failed due to abuse, neglect, improper maintenance or unapproved modifications.

PACCAR recommends that any service parts used for maintenance, repair or replacement of emission control systems be new or genuine PACCAR approved rebuilt parts and assemblies, and that the engine be serviced by an authorized PACCAR engine dealer or an authorized Cummins Distributor. Your vehicle contains air, fuel, and electrical components that may affect engine emission controls. The use of non-genuine engine or vehicle replacement parts that are not equivalent to the PACCAR engine or OEM vehicle manufacturer's original part may impair the engine and vehicle emissions control system from working or functioning effectively, and may jeopardize your emissions warranty coverage.

The owner may elect to have maintenance, replacement or repair of the emission control parts performed by a facility other than an authorized PACCAR engine dealer or an authorized Cummins Distributor and may elect to use parts other than new or genuine approved rebuilt parts and assemblies for such maintenance, replacement or repair; however, the cost of such service or parts and subsequent failures resulting from such service or parts will not be covered under this emission control system warranty, except for " *Emergency Repairs* on page 84 ."

#### **PACCAR Responsibilities**

State of California emissions statement on PACCAR's responsibility.

The warranty coverage begins when the engine is delivered to the first purchaser or first lessee. Repairs and service will be performed by any authorized PACCAR engine dealer or an authorized Cummins Distributor using new or genuine PACCAR approved rebuilt parts and assemblies. PACCAR will repair any of the emission control parts found by PACCAR to be defective without charge for parts or labor (including diagnosis which results in determination that there has been a failure of a warranted emission control part).

#### **Emergency Repairs**

State of California emissions statement on emergency repairs.

In the case of an emergency where an authorized PACCAR engine dealer or an authorized Cummins Distributor is not available, repairs may be performed by any available repair location or by any individual using any replacement parts. A part not being available within 30 days or a repair not being complete within 30 days constitutes an emergency. PACCAR will reimburse the owner for expenses (including diagnosis), not to exceed the manufacturers suggested retail price for all warranted parts replaced and labor charges based on the manufacturers recommended time allowance for the warranty repair and the geographically appropriate hourly labor rate.

Replaced parts and paid invoices must be presented at an authorized PACCAR engine dealer or an authorized Cummins Distributor as a condition of reimbursement for emergency repairs not performed by an authorized PACCAR engine dealer or an authorized Cummins Distributor.

#### Warranty Limitations

State of California emissions statement on warranty limitations.

Your sole and exclusive remedy against PACCAR and the selling dealer arising from your purchase and use of this engine is limited to the repair or replacement of "warrantable failures" at authorized United States and Canadian PACCAR engine dealers or an authorized Cummins Distributor, or an authorized PACCAR engine facility where applicable, subject to PACCAR's time, mileage, and hour limitations of the engine warranty. The maximum time, mileage and hour limitations of the engine warranty begin running on the date of delivery to the first purchaser or first lessee. The accrued time, mileage, or hours is calculated when the engine is brought into an authorized dealer for correction of warrantable failures.

Failures, other than those resulting from defects in material or factory workmanship. are not covered by this warranty. PACCAR is not responsible for failures or damage resulting from what PACCAR determines to be abuse or neglect, including, but not limited to: damage due to accident: operation without adequate coolants or lubricants; overfueling; overspeeding; lack of maintenance of lubricating, cooling or intake systems; improper storage, starting, warm-up, run-in or shutdown practices; failure to perform regeneration in a timely manner; unauthorized modifications of the engine. PACCAR is also not responsible for failures caused by incorrect oil or fuel or diesel exhaust fluid or by water, dirt or other contaminants in the fuel, oil, or diesel exhaust fluid. Failure of replacement parts used in repairs due to the above nonwarrantable conditions is not warrantable

PACCAR is not responsible for failures resulting from improper repair or the use of parts which are not genuine PACCAR approved parts.

PACCAR is not responsible for the material and labor costs of emission control parts and assemblies replaced during Scheduled Maintenance of the engine as specified in PACCAR Operator's Manuals.



## **Coverage Pricing**

Extended Transmission Coverage must be purchased within one year of the delivery of the vehicle. Pricing shown in this brochure is applicable to Extended Transmission Coverage purchased in 2024.

Suggested retail prices are established for each transmission vocational model/vocation combination.

The terms and conditions under which Allison Transmission offers Extended Transmission Coverage are set forth on the back of the Extended Transmission Coverage Agreement Registration, available from any Allison Authorized Distributor or Dealer.

## **Extended Transmission Coverage**

In addition to Standard Limited Warranty, Allison transmissions listed in this brochure are eligible for Extended Transmission Coverage. Extended Transmission Coverage begins at the end of the Standard Limited Warranty period and increases the coverage period. Extended Transmission Coverage is available for purchase through Allison Authorized Distributors and Dealers. Details for Extended Transmission Coverage are shown on the following charts. REQUIREMENTS: Use of Allison Approved TES 668° or TES 295° transmission fluid\*\* and Genuine Allison Filters is required. Failure to use Allison Approved TES 668 or TES 295 transmission fluid and Genuine Allison Filters will result in no coverage for repair beyond Standard Limited Warranty coverage. Transmissions that are not OEM factory filled with Allison Approved TES 668 or TES 295 transmission fluid and Genuine Allison Filters must have Allison Approved TES 668 or TES 295 transmission fluid and Genuine Allison Filters installed at the time of Extended Transmission Coverage purchase. Transmissions that are not OEM factory filled with Allison Approved

TES 668 or TES 295 transmission fluid, or transmissions operating with non-TES 668 or non-TES 295 fluids, must be drained and filled with Allison Approved TES 668 or TES 295 transmission fluid to achieve 100% concentration. One hundred percent concentration is not achieved until the second consecutive fluid change using Allison Approved TES 668 or TES 295 transmission fluid. The second consecutive fluid change must be achieved at the time of Extended Transmission Coverage purchase.
