Re: Contract Authorization – FY 2026 Consolidated Planning Grant (CPG) (Case # 283-2025)

Executive Summary

Approval of the attached ordinance would authorize the City Manager to execute, as the contractor for the Columbia Area Transportation Study Organization (CATSO), the contracts associated with the FY 2026 Consolidated Planning Grant (CPG) funds with the Missouri Highways and Transportation Commission (MHTC) that are derived from the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA).

Discussion

The attached ordinance seeks Council authorization to permit the City Manager to execute the FY 2026 Consolidated Planning Grant (CPG) contracts with the Missouri Highways and Transportation Commission (MHTC). The approval of the attached ordinance and granting the City Manager authorization to execute the agreement are necessary to facilitate the annual contract renewal process of an ongoing grant program. If the authorization is granted, the City would be provided a total of \$952,600 in federal CPG funding for FY 2026 transportation planning purposes.

For reference purposes, the MoDOT grant number associated with this project is MP32601C. It should be further noted that the total CPG funding allocation includes a 2.5% PL set aside of \$17,815 which is identified by grant number of MP32602C. Finally, the Federal FMIS number is 00FY326 and CFDA number for the consolidated planning funds is 20.505, the same as the Federal Highway Administration PL number.

The 2.5% PL set aside is 100% reimbursable, meaning there is no 20% city match to access the funds, provided such funds are expended on qualifying federal transportation-related activities. When this 2.5% PL set aside is removed, the balance of CPG grant funds being made available to the City is \$1,168,445. Of this amount, 80% is the federal share (\$934,785) and 20% is the city share (\$233,600).

A copy of the CPG agreement is attached for review. Appendix A of the agreement provides funding details per individual work activities.
