Re: Local Public Health Disparities Initiative Services Contract Amendment 03

Executive Summary

An ordinance authorizing the City Manager to sign the Local Public Health Disparities Initiative Service Contract Amendment 03 between the City of Columbia, MO and the Missouri Department of Health and Senior Services for the period of March 1, 2022 through May 31, 2025 in an amount not to exceed \$566,739.22.

Discussion

COVID-19 has disproportionately affected populations placed at higher risk and who are medically underserved, including racial and ethnic minority groups, and people living in rural communities who are at higher risk of exposure, infection, hospitalization and mortality. The purpose of this contract is to reduce COVID-19-related health disparities; improve and increase testing and contact tracing among populations at higher risk and that are underserved. The funding is also to help PHHS and key partners implement a coordinated and holistic approach that builds on culturally, linguistically and locally tailored strategies and best practices to reduce COVID-19 risk. The first amendment to this agreement extended the contract period by twelve months to May, 2024. This amendment increases the amount of the agreement from \$466,881.30 to 566,739.22 and extends the term through May 31, 2025. The appropriation for this agreement was included on the September 16, 2024 FY25 Budget amendment sheet.
