Re: Amendment to an Agreement with Wilkes Blvd. United Methodist Church

Executive Summary

A resolution authorizing the City Manager to sign an amendment to an agreement with Wilkes Boulevard United Methodist Church for additional homeless drop-in center services.

Discussion

This is an amendment to the agreement with the Wilkes Boulevard United Methodist Church (WBUMC) for homeless drop-in center services provided through the Turning Point program. The City's FY2024 budget included \$225,989.00 specifically for the purposes of providing the additional funding needed for the Turning Point program to extend its hours of operation to 3:30 p.m. Monday-Friday. Turning Point currently operates 7:30 a.m. – 12:30 p.m. Monday-Friday and from 12:30 – 4:30 p.m. on Sundays. Contingent upon the approval of this amendment, WBUMC plans to begin the extended weekday hours on January 1, 2024.

As proposed, the amendment includes two additional renewal terms for 2024 and 2025. For each renewal term, the amendment: increases the number of contracted units of the homeless drop-in center service from 11,210.84 to 17173.93, increases the unit rate for the homeless drop-in center service from \$10.48 to \$20.00, increases the total allowable compensation from \$183,489.58 to \$409,478.58; and modifies the payment terms.
