### What is a Capital Improvement Plan (CIP)

- Multi-year plan for capital improvements
- Provides a schedule with a revenue plan that fits available resources
- Used as a tool to implement recommendations from City Master Plans

- Capital Improvement Sales Tax
- Parks Sales Tax
- Transportation Sales Tax
- Public Improvement Funds
- Bonds
- General Fund
- Enterprise Revenue
- Grants

March	Final project requests are submitted by departments
March/April	Requests reviewed by City Manager and CIP Dashboard updated
July	The Planning & Zoning Commission reviews the CIP Dashboard
August	CIP, with funding needs, is presented to Council; CIP Hearing is held
September	CIP document is prepared, reflecting any changes and approved by Council

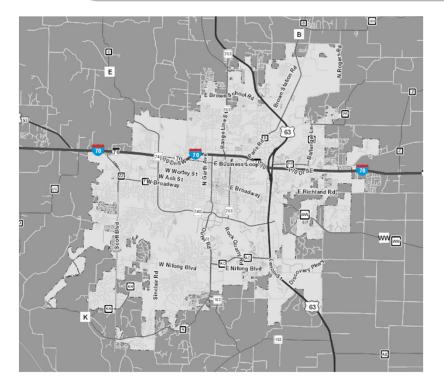
