Re: Authorizing construction of the Capri Drive Storm Drainage Project; calling for bids through the Purchasing Division or authorizing a contract for the work using a term and

supply contractor.

#### **Executive Summary**

Staff has prepared for council consideration an ordinance authorizing construction and issuing a contract for the work or a bid call through the Purchasing Division for the Capri Drive Storm Drainage Project, as shown on the attached diagram. The public hearing for this project was held on July 6, 2021. The resolution estimate for this project is \$284,000 and will be paid from Stormwater Utility funds.

#### Discussion

The Capri Drive Storm Drainage Project will install approximately 427 feet of stormwater pipe and 7 stormwater structures along with 201 feet of sanitary sewer pipe and 4 sanitary sewer structures, as shown on the attached diagram. Staff anticipates utilizing an existing term and supply contract for this project. However, this ordinance authorizes construction either through the City's term and supply contracts or by bidding through Purchasing, whichever is most appropriate. Capri Drive (formerly known as Rockhill Road) was included in the list of proposed projects in the 2015 ballot initiative to increase monthly stormwater billing rates. This project is financed from Stormwater Utility funds. Construction is expected in 2023.

#### Fiscal Impact

Short-Term Impact: The resolution estimate is \$284,000 paid from the Stormwater Utility funds. Long-Term Impact: By preventing collapse and emergency repairs, this project will have a large beneficial, though unquantifiable, fiscal effect.
