Presentation of the IPC, IMC and IFGC Review

- Matt Young presented the 2021 IPC, IFGC and IMC and stated most of the changes were simply clarification and reformatting with the exception of Section 403.2 Separate Facilities, Exception #6 of the IPC which states that: Sperate facilities shall not be required where rooms having both water closets and lavatory fixtures are designed for use by both sexes and privacy for water closets is provided in accordance with Section 405.3.4. Urinals shall be located in an area visually separated from the remainder of the facility or each urinal that is provided shall be located in a stall.
- It was proposed by Matt Young to delete Exception #6 in its entirety with Rick Shanker seconding the motion.
- It was discussed by the BCCC members and determined that with the vagueness of the partition requirements of Section 405.3.5 and potential buildings and use groups where the exception could be utilized that it would not be feasible.

 The BCCC voted unanimously to delete Exception #6 of Section 403.2 Separate Facilities of the 2021 IPC.
