Re: Authorizing the Temporary Restriction or Closure of Driving Lanes, Parking Lanes, and

Sidewalk for two (2) University of Missouri demolition projects.

Executive Summary

Staff has prepared for Council consideration a resolution authorizing Sircal Contracting, Inc. to temporarily restrict driving lanes and close parking lanes and sidewalk for the following University of Missouri demolition projects:

The Professional Building – temporarily close sidewalk along University Avenue between South Ninth Street and Hitt Street from June 6, 2022 through October 7, 2022.

Parker Hall, Noyes Hall, and the Old Student Health Building - temporarily restrict driving lanes and close parking lanes and sidewalk along South Sixth Street between Elm Street and East Stewart Road from June 13, 2022 through October 7, 2022.

Discussion

The driving lane, parking lane, and sidewalk restrictions/closures include:

- Closure of the north sidewalk of University Avenue between South Ninth Street and Hitt Street from June 6, 2022 through October 7, 2022.
- Restriction of both driving lanes and closure of both parking lanes and east sidewalk of South Sixth Street between Elm Street and East Stewart Road from June 13, 2022 through October 7, 2022.

Sircal Contracting, Inc. will be demolishing The Professional Building, Parker Hall, Noyes Hall, and the Old Student Health Building on the Campus of the University of Missouri. Staff has reviewed the attached traffic control plans and has no other issues with their request.

The University of Missouri and/or its contractor will be responsible for all signs and barricades necessary for the protection and convenience of the general public. The University of Missouri is exempt from any public inconvenience fee.
